**Flat 1 34 Riggindale Road London SW16 1QJ** Erection of a single storey ground floor rear extension. 18/04704/FUL

**237 - 237B Streatham High Road London SW16 6EN**  
Conversion of the upper floors to provide 3 studio units. 18/03894/FUL

**33 Bellefields Road London SW9 9UH** Erection of a rear mansard roof extension and installation of 2 dormer windows. 18/05022/FUL

**17 Bellefields Road London SW9 9UH** Redevelopment of the site, involving the demolition of existing building and erection of a five storey building plus basement to provide a flexible use (Class A3 and/or A4 - 453sqm) at part basement and part ground floors and office floorspace (Class B1 - 1885sqm) at part basement, part ground and first to fourth floor levels, together with provision of cycle store and the installation of a green roof and plant on roof. 18/04311/FUL

**37 Gauden Road London Lambeth SW4 6LR** Erection of a single storey ground floor rear conservatory. 18/04955/FUL

**10 Albert Square London SW8 1BT** Internal and external alterations to basement comprising the alteration to the hall door, removal of the bathroom and storage to create a TV room with a new window, erection a wall to create a bathroom with a new door and resize the existing front bedroom, erection a wall to substitute the position of rear bedroom with an open-plan kitchen/living room including removal of the load bearing wall party and installation a new door to the rear bedroom together with enlargement of 1 rear window plus removal of side internal chimney footing both involving other associated works. Internal alterations to First Floor Flat (Flat B) to create 1 additional bedroom (1x2-bed). Provision of refuse and cycle storage. 18/04982/FUL
