INTRODUCTION OF LADYWELL WEST (LW) CONTROLLED PARKING ZONE

The Lewisham (Free Parking places, Loading Places and Waiting, Loading and Stopping Restrictions)

(Amendment No. *) Order 201*

The Lewisham (Charged-For Parking Places) (Amendment No. *)

Order 201*

1. NOTICE IS HEREBY GIVEN that Lewisham Borough Council propose to make the above-mentioned Orders under the provisions of section 6, 45, 46, 49 and 124 of and part IV of Schedule 9 of the Road Traffic Regulation Act 1984, as amended.

2. The general effect of the Orders would be to:-

- A. (a) introduce a Controlled Parking Zone (CPZ) to be called Ladywell West (LW) CPZ which would operate between 10am and 12noon on Mondays to Fridays inclusive (the 'LW CPZ controlled hours') and would include all those parts of the roads specified in the Schedule to this Notice that are public highway (the 'LW CPZ roads');
- (b) provide a combination of single yellow line waiting restrictions, resident permit parking places and shared-use (permit and pay and display) parking places that would operate during the LW CPZ controlled hours in the LW CPZ roads and alter the provision of double yellow line "at any time" waiting restrictions in those roads so that they are provided across certain drop kerbs and either provided, lengthened or shortened at certain junctions;
- (c) provide free parking places (maximum stay 30 minutes, 'no return' for 1 hour) operating during the LW CPZ controlled hours on the south side of Brookbank Road, outside Nos. 153 to 161 Brookbank Road; and
- (d) provide disabled persons blue badge permit holder parking places at certain locations in Fossil Road, Halesworth Road, Overcliff Road, Sandrock Road and Undercliff Road, replacing any existing advisory disabled persons parking places within LW CPZ. [Note: disabled blue badge holders would be eligible for a free residents' disabled permit].
- B. Provide that the charges for permits would be: Resident's permit: £120 per year; Visitor's permit: £1.40 for a one-hour permit; £10.00 for a book of 10 one-hour permits; £2.80 for a five-hour permit; £5.60 for a one-day permit; and £20 for a one-week permit; Resident's Carer's permit: FREE; and Business permit: £500 per year.

3. The LW CPZ Order would provide that:

- (a) residents' permits, business permits, visitors' permits and residents' carers' permits may be issued, on payment of the appropriate charge to a person who is the keeper of a passenger vehicle (having 12 passenger seats or less), certain goods carrying vehicles, a motor cycle and invalid carriages, providing that in the case of:-
- (i) a residents' permit, resident's carers' permit or visitors' permit, they are a resident of a street specified in paragraph (b) below;
- (ii) a business permit, they have a business in a street specified in paragraph (b) below;
- (b) the properties eligible for LW CPZ permits would be: Loampit Hill (odd numbers 21 to 51 inclusive); and properties within the streets / lengths of street specified in the Schedule to this Notice;
- (c) to provide that only vehicles displaying a valid permit showing the zone identifying letters LW may use the resident permit or shared-use parking places (without using the telephone or electronic payment system) within LW CPZ; and
- (d) to provide that the charge for leaving a vehicle in a shared-use parking place, paid via the telephone or electronic payment system would be £0.35 per 15 minutes up to £2.80 for a maximum stay of 2 hours with no return permitted to that parking place for one hour.
