

# Transport for London Notice

## ROAD TRAFFIC REGULATION ACT 1984

### THE A4 (KNIGHTSBRIDGE, CITY OF WESTMINSTER) (TEMPORARY PROHIBITION OF STOPPING) ORDER 2019

1. Transport for London hereby gives notice that it intends to make the above named Traffic Order under section 14(1), (5), (7) and 15(2) of the Road Traffic Regulation Act 1984 and is satisfied that these works will last in excess of 18 months for the purpose specified in paragraph 2. The effect of the Order is summarised in paragraph 3.
2. The purpose of the Order is to enable redevelopment works to take place at the Berkeley Hotel, No.40 Wilton Place.
3. The effect of the Order will be to prohibit any vehicle from stopping at any time at the:
  - (1) Southern kerb-line of Knightsbridge, with the exception of authorised vehicles being loaded or unloaded, from a point 7 metres west of the extended eastern building line of Nos.37 to 39 Knightsbridge to the extended Northern building line of No.33 Knightsbridge;
  - (2) Southern kerb-line of Knightsbridge from a point 7 metres West of the extended Western boundary of Nos. 37 to 39 Knightsbridge to a point 18 metres in a Westerly direction except those loading and unloading, 10am to 4pm, Maximum stay 20 mins;
  - (3) Eastern kerb-line of Old Barrack Yard from a point opposite the extended Northern building-line of No.33 Knightsbridge for a distance of 4 metres in a Southerly direction;
  - (4) Western kerb-line of Old Barrack Yard from the extended Northern building-line of No.33 Knightsbridge for a distance of 4 metres in a Southerly direction;
  - (5) Southern kerb-line of Knightsbridge from a point opposite the extended Northern building-line of No.33 Knightsbridge to a point 22 metres west of the Western building-line of No.25 Knightsbridge.

For the purposes of this Order authorised vehicles are those vehicles required for the redevelopment of the Berkeley Hotel, No.40 Wilton Place.

The Order will be effective at certain times from 12:01 AM on the 8th May 2019 until the works have been completed. The prohibition will apply only during such times and to such extent as shall from time to time be indicated by traffic signs.

4. The prohibitions will not apply in respect of:
  - (1) any vehicle being used for the purposes of those works or for fire brigade, ambulance or police purposes;
  - (2) anything done with the permission or at the direction of a police constable in uniform or a person authorised by Transport for London.
5. The Order will be revoked upon completion of these works.
