ROAD TRAFFIC REGULATION ACT 1984

THE A2 GLA ROAD (NEW CROSS ROAD, LONDON BOROUGH OF LEWISHAM) (TEMPORARY PROHIBITION OF TRAFFIC, STOPPING, SUSPENSION OF BUS LANES AND 20 MPH SPEED LIMIT) ORDER 2019

- 1. Transport for London in consultation with the London Borough of Lewisham hereby gives notice that it has made the above named Traffic
- Order under section 14(1) of the Road Traffic Regulation Act 1984 for the purpose specified in paragraph 2. The effect of the Order is summarised in paragraph 3.
- 2. The purpose of the Order is to allow gas main replacement works to take place on New Cross Road.
- 3. The effect of the Order will be to prohibit any vehicle from: (I) Stopping on New Cross Road between its junctions with Queen's
 - Road and Deptford High Street; (2) turning left from New Cross Road into Goodwood Road;
 - (3) exiting the eastern access road from the retail site next to No.263 New Cross Road;
 - (4) turning right from New Cross Road into the western access road to the retail site next to No.263 New Cross Road;
 - Stopping in the parking bays Nettleton Road on the side of Nos. 241 and 243 New Cross Road;
 - Stopping in the parking bays Hart's Lane on the side and opposite of No. 255 New Cross Road;
 - Stopping in the parking bay and loading bay on Jerningham Road on the side and opposite of No. 256 New Cross Road; Stopping in the parking bay on Goodwood Road on the side of No.
 - 275 New Cross Road; Stopping on Clifton Rise between its junction with New Cross Road
 - and No.9a Clifton Rise; (10) Stopping on Pagnell Street between its junction with New Cross Road and the extended common boundary of Nos. 10-12 and 14-16 Pagnell Street; GLA/2019/0259 2
 - (11) Stopping on Mornington Road between its junctions with New Cross Road and Stanley Street;
 - (12) Stopping on Deptford High Street between its junction with New Cross Road and the extended common boundary of Nos. 8 to 12 and 14 Deptford High Street;
 - (13) Exceeding a speed of 20 MPH on New Cross Road between its junctions with Queen's Road and Deptford High Street.
 - The Order will also permit all vehicles to use the eastbound and westbound bus lanes on New Cross Road between its junctions with
 - Queen's Road and Deptford High Street. The Order will be effective between 5:00 AM on 25th May 2019 and 6:00 PM on 24th November 2020 or until the works has been completed. The prohibitions will apply only during such times and to such extent as shall from time to time be indicated by traffic signs.
- 4. The prohibitions will not apply in respect of:
- (I) any vehicle being used for the purposes of those works or for fire brigade, ambulance or police purposes;
- (2) anything done with the permission or at the direction of a police
- constable in uniform or a person authorised by Transport for London. 5. At such times as the prohibitions are in force an alternative route will be
 - indicated by traffic signs. For the banned right turn into western access road to the retail site next to No.283 New Cross Road via Jerningham Road, Pepys Road, Arbuthnot Road, Erlanger Road and New Cross Road to normal route of travel. For HGVs via New Cross Road, Queen's Road, Peckham High Street, Peckham Road, Camberwell Church Street, Camberwell New Road, Brixton Road, Kennington Park Road, Kennington Lane, Newington Butts, Elephant and Castle, New Kent Road, Old Kent Road and New Cross Road to normal route of travel. For Goodwood Road via New Cross Road, Clifton Rise and Batavia Road to normal route of
