VARIATION AND FORMAL DESIGNATION OF THE WAITING AND LOADING RESTRICTIONS - ABBOTSWOOD ROAD, BRAXTED PARK, GARRAD'S ROAD, MOUNT EPHRAIM LANE, STREATHAM COMMON SOUTH AND WOODFIELD AVENUE

[NOTE: This Notice is about the variation and formal designation of waiting and loading restrictions (indicated by double yellow lines) in certain lengths of Abbotswood Road, Braxted Park, Garrad's Road, Mount Ephraim Lane, Streatham Common South and Woodfield Avenue.)

1. NOTICE IS HEREBY GIVEN that the Council of the London Borough of Lambeth on 19th June 2019 made the Lambeth (Waiting and Loading Restriction) (Amendment No. 285) Order 2019, under sections 6 and 124 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984. The Order will come into force on 1st July 2019.
2. The general effect of the Order will be to impose at any time waiting restrictions in the lengths of road specified in the Schedule to this Notice.
3. The Order would also contain amendments that ensure the existing Orders correspond to the on-street road markings and traffic signs.
4. The ban on waiting by vehicles is necessary to improve visibility for drivers and pedestrians and maintain clear access routes at road junctions. The changes to the waiting and loading restrictions (yellow lines) were advertised previously as part of a wider scheme which included the extension of the existing speed table in Woodfield Avenue and removal of the traffic island, these elements of the scheme will not be continued but the associated landscaping of adjacent footways will be continued with some modifications.

If any person wishes to question the validity of the Order or of any of its provisions on the grounds that it or they are not within the powers conferred by the Road Traffic Regulation Act 1984, or that any requirement of that Act or any instrument made under that Act has not been complied with, that person may, within 6 weeks from the date on which the Orders are made, apply for the purpose to the High Court.

SCHEDULE

Abbotswood Road, both sides, between its junction with Bedford Hill and Garrad's Road and a point 7.7 metres south-east of the south-eastern boundary wall of No. 65 Abbotswood Road, measured on the north-east side. **Braxted Park**, both sides, between Streatham Common South and a point 10 metres south-east of Streatham Common South. **Garrad's Road**, the east and north-east side, between its junction with Bedford Hill and a point 38.5 metres north of Woodbourne Avenue. **Mount Ephraim Lane**, (i) the north-west side, between Woodfield Avenue and a point 4 metres south-west of the north-easternmost wall of No. 1 Garrad's Road; and (ii) the south side, between Woodfield Avenue and a point 4.5 metres west of the easternmost wall of No. 1 Garrad's Road. **Streatham Common South**, (i) both sides, between a point 10 metres south-west of Braxted Park and a point 10 metres north-east of Braxted Park; (ii) both sides, between a point 12.5 metres south-west of Copley Park and a point 13.5 metres north-east of Copley Park; (iii) the north-west side, between the length which is GLA side road (indicated by double red lines) and a point 1 metre south-west of a point opposite the common boundary of Nos. 4 to 5 and No. 6 Streatham Common South; (iv) the south-east side, between the length which is GLA side road (indicated by double red line) and the common boundary of Nos. 4 to 5 and No. 6 Streatham Common South. **Woodfield Avenue**, (i) the north-west side, between Abbotswood Road and 12.4 metres north-east of the south-western wall of Nos. 78 to 84 Woodfield Avenue; and (ii) the south-east side, between its junction with Garrad's Road and a point 16 metres north-east of the south-western wall of Nos. 78 to 84 Woodfield Avenue.
