- this Notice (these parking places would operate at any time and be for the use of vehicles displaying a disabled person's "blue badge" only); and (4) formally remove or provide other types of parking space as and where it is required, to accommodate the removal and provision of the disabled person's parking places referred to in
- paragraphs 2(2) and 2(3) above. 3. The Orders are necessary to provide new disabled persons' parking places where they are needed and to remove certain disabled persons' parking places where they are no longer required. The parking places referred to in paragraph 2(2) above are no longer on the ground
- and the ones referred to in paragraph 2(3) above have already been provided, on an informal basis, so the proposed orders are also required to reflect the parking situation that currently applies on the ground and enable enforcement to be carried out where necessary. 4.
