THE GLA ROADS AND GLA SIDE ROADS (WESTMINSTER) RED ROUTE CONSOLIDATION TRAFFIC ORDER 2008 A202 GLA ROADS (BRESSENDEN PLACE, BRIDGE PLACE, NEATHOUSE PLACE, WILTON ROAD AND VAUXHALL BRIDGE ROAD) VARIATION ORDER 2019
THE GLA ROADS (CITY OF WESTMINSTER) (BUS PRIORITY) CONSOLIDATION TRAFFIC ORDER 2009 A202 GLA ROADS (NEATHOUSE PLACE AND WILTON ROAD) VARIATION ORDER 2019

1. Transport for London, hereby gives notice that it intends to make the above named Order under section 6 of the Road Traffic Regulation Act 1984.
2. The general nature and effect of the Orders will be to formalise the existing:
 - (1) 30 metre Licensed Taxis only Bay opposite No.16 Hobart Place;
 - (2) 10 metre Solo Motor Bicycles only bay opposite Nos 318-322 Vauxhall Bridge Road;
 - (3) 15 metre Loading, Unloading and Disabled Persons' Vehicles bay on the northern side of Bridge Place outside No.130 Bridge Place (Stockley House);
 - (4) 15 metre Loading, Unloading and Disabled Persons' Vehicles bay on the north-eastern side of Vauxhall Bridge Road and outside Nos.318-324 No Stopping at Any Time, Except loading Max 20 Mins and disabled persons' vehicles max 3 hours;
 - (5) 15 metre Loading and Unloading only bay opposite Nos 318-322 Vauxhall Bridge Road No Stopping at Any Time, Except 10am-4pm, loading Max 20 Mins;
 - (6) 22 metre of double red lines 'No Stopping at Any Time' outside No.292 Vauxhall Bridge Road;
 - (7) 9 metre of double red lines 'No Stopping at Any Time' opposite Nos.314-316 Vauxhall Bridge Road;
 - (8) 14 metre of double red lines 'No Stopping at Any Time' adjacent to No.173 Victoria; Street and sited on Vauxhall Bridge Road;
 - (9) 60 metre south-westbound Bus lane on the north-western side of Neathouse Place;
 - (10) At any Time Bus only route from the northern kerb of Neathouse Place to the junction with Victoria Street;

The Order also:

- (11) removes the 6 metre borough bay on outside No.130 Bridge Place (Stockley House);
 - (12) installs a 6 metre Solo Motor Bicycles only bay on the northern side of Bridge Place outside No.130 Bridge Place (Stockley House);
 - (13) amends the Maximum Loading time of the Loading, Unloading and Disabled Persons' Vehicles bay on the western side of Bressenden Place, opposite Portland House from to No Stopping Mon-Sat 8am - 7pm Except 10am-4pm loading max 40 mins and disabled persons' vehicles max 3 hours
3. The roads which would be affected by the Order are A202 Bressenden Place, Neathouse Place, Wilton Road, Victoria Bridge Road and Bridge Place.
 4. A copy of the Order, a statement of Transport for London's reasons for the proposals, a map indicating the location and effect of the Order and copies of any Order revoked, suspended or varied by the Order can be inspected during normal office hours at the offices of:

Objections and other representations may be communicated to other persons who may be affected.
