

# Transport for London Notice

## THE A200 GLA ROAD AND SIDE ROADS (TOOLEY STREET AND JAMAICA ROAD, LONDON BOROUGH OF SOUTHWARK) (TEMPORARY 20 MPH SPEED LIMIT AND PROHIBITION OF TRAFFIC AND STOPPING) ORDER 2019

1. Transport for London, having consulted the London Borough of Southwark, hereby gives notice that it intends to make the above named Traffic Order under section 14(1) of the Road Traffic Regulation Act 1984 for the purpose specified in paragraph 2. The effect of the Order is summarised in paragraph 3.
2. The purpose of the Order is to enable cycle super highway construction works to take place on or near the A200 Tooley Street and Jamaica Road.
3. The effect of the Order will be to prohibit any vehicle from:
  - (1) exceeding a speed of 20 mph on the A200 Tooley Street and Jamaica Road between its junctions with Potters Fields and Lower Road, including Rotherhithe Roundabout;
  - (2) exceeding a speed of 20 mph on the A200 Lower Road between its junctions with Surrey Quays Road and Jamaica Road;
  - (3) entering, exiting, stopping or proceeding on the A200 Tooley Street and Jamaica Road between its junctions with Fair Street and Lower Road, including Rotherhithe Roundabout;
  - (4) entering or exiting Fair Street at its junction with the northbound carriageway of the A200 Tower Bridge Road;
  - (5) entering, exiting stopping or proceeding on Queen Elizabeth Street between its junctions with the A200 Tooley Street and the A100 Tower Bridge Road;
  - (6) entering, exiting or proceeding on George Row between its junctions with the A200 Jamaica Road and Sugar Lane. Local access will be maintained;
  - (7) entering, exiting or proceeding on Cathay Street between its junctions with the A200 Jamaica Road and Paradise Street. Local access will be maintained between its junction with Paradise Street and a point 26 metres north of its junction with the A200 Jamaica Road;
  - (8) stopping on Cathay Street between its junctions with the A200 Jamaica Road and a point 26 metres northwards.

The Order will also:

- (9) permit all vehicles to turn left from the northbound carriageway of the A100 Tower Bridge Road into the A200 Tooley Street;
- (10) suspend the one-way operation on the western arm of Fair Street between its junctions with the A100 Tower Bridge Road and the A200 Tooley Street permitting two-way operation;
- (11) suspend the one-way operation on Boss Street and Lafone Street between their junctions with the A200 Tooley Street and Queen Elizabeth Street permitting two-way operation;
- (12) suspends the one-way operation on Mill Street between its junctions with the A200 Jamaica Road and Wolseley Street permitting two-way operation;
- (13) permit all vehicles to use all bus lanes on the A200 Tooley Street and Jamaica Road between its junctions with Potters Fields and Lower Road.

The Order will be effective at certain times from 6:00 AM on the 5th July 2019 until 6:00 PM on the 4th February 2021 or when the works have been completed whichever is the sooner. The prohibition will apply only during such times and to such extent as shall from time to time be indicated by traffic signs.

These works will be carried out in phases and not all of restrictions will occur simultaneously. Any references to closing Tooley Street, Jamaica Road or Lower road to through traffic are only included to cover unforeseen circumstances.

4. The prohibitions will not apply in respect of:
  - (1) any vehicle being used for the purposes of those works or for fire brigade, ambulance or police purposes;
  - (2) anything done with the permission or at the direction of a police constable in uniform or a person authorised by Transport for London.
5. At such times as the traffic prohibitions are in force alternative routes will be indicated by traffic signs via local roads.
