Road Traffic Regulation Act 1984

The Greenwich and Lewisham (Various Roads) (Blackheath Fireworks) (Temporary Prohibition of Traffic) Order 2019

NOTICE IS HEREBY GIVEN that Lewisham Council intends to make this temporary traffic order with Greenwich Council's and Transport for London's consent under the provisions of section 16A of the Road Traffic Regulation Act 1984 supplemented by the provisions of section 287 of the Highways Act 1980 in order to facilitate the holding of the 2019 Blackheath Firework Display. The effects of the order will be as indicated below.

- 1.** Road closures, prohibiting any vehicle from entering or proceeding in All Saints Drive; Angerstein Lane; Bennett Park; Blackheath Grove; Blackheath Village; Charlton Way; Cresswell Park; Duke Humphrey Road; Goffers Road; Hare and Billet Road; Hatcliffe Close; Haynes Close; Lawn Terrace; Long Pond Road; Maze Hill between Vanbrugh Park and Shooters Hill Road; Montpelier Row; Montpelier Vale; Mounts Pond Road between Granville Park and Hare and Billet Road; Paragon Place; Prince Charles Road; Prince of Wales Road; Royal Parade; St. German's Place; South Row; Talbot Place; Tranquil Vale; Tristan Square; Vanbrugh Terrace between Maze Hill and Shooters Hill Road; and Wemyss Road.
- 2.** (1) No entry for vehicles:- From Stratheden Road into Langton Way western arm, St. John's Park western arm, Vanbrugh Park or Heathway; From Westcombe Park Road into Beaconsfield Road southern arm, Mycenae Road southern arm, Vanbrugh Fields, Vanbrugh Park Road or Vanbrugh Park Road West; Into Collins Street from Baizdon Road or Hurren Close; Into Maze Hill south of Westcombe Park Road from Maze Hill north of Westcombe Park Road or from Vanbrugh Park; and into Westbrook Road from Kidbrooke Park Road; (2) Alternative routes for traffic affected will be via neighbouring local roads.
- 3.** One-way working in (i) Mounts Pond Road between Granville Park and Eliot Hill in a westerly direction, and (ii) in Lee Park in a southerly direction.
- 4.** No parking, prohibiting all traffic except local buses at bus stops and vehicles displaying valid permits parked at designated parking places from stopping or waiting in All Saints Drive; Angerstein Lane; Blackheath Park; Blackheath Village; Charlton Way; Cresswell Park; Eliot Hill; Goffers Road; Hare and Billet Road; Hatcliffe Close; Haynes Close; Lawn Terrace; Lee Park; Lee Road; Lee Terrace; Maze Hill between Shooters Hill Road and Charlton Way; Montpelier Row; Montpelier Vale; Mounts Pond Road; Prince Charles Road; Prince of Wales Road; Royal Parade; St. Austell Road; Stratheden Road; Tranquil Vale; Tristan Square; and Wat Tyler Road.
- 5.** Exemption will be provided in the order for vehicles engaged on the annual November fireworks display, vehicles being used for ambulance, fire brigade or police purposes and anything done with the permission or at the direction of a civil enforcement officer or a police officer in uniform. Irrespective of any provisions, exceptions or exemptions in this or any other order the order imposes a duty to move a vehicle on if so instructed by a civil enforcement officer or police officer in uniform.
- 6.** The order will come into force on the 2nd November 2019 to remain in force for that day only. The prohibitions and restrictions will apply as, when and to the extent signed on the highway.

(Informative note: In many cases there are no alternative routes available; for the greater part measures will only be in place for the evening only.)
