section 90A of the Highways Act 1980:-(A) to construct: (a) Two "flat top" road humps in Beckenham Hill Road, with a gap of between 200-300mm at the kerb-lines or drainage channel. The road humps to be constructed with an elevated section of carriageway of 75mm (+/- 5mm) at its highest point with a flat top of a minimum of 6 metres in length and ramps with a length of 1.5 metres with the

- centreline at the following locations:-
 - (i) 52 metres southwest of the centre of its junction with Dunfield Road.
 (ii) 71 metres northeast of the centre of its junction with the cycle track from
- Sedgehill Road. (b) Road humps known as "speed cushions" in Beckenham Hill Road. The speed
- cushions to be constructed 75mm high (+/- 5mm), 2.5 metres long, 1.7 metres wide, on/off ramps 1:8, sides 1:4, with the centreline at the following locations:

 (i) 2 across the carriageway 11 metres north-east of the centre of its junction
 - with Primrose Close.
 - (ii) 2 across the carriageway 61 metres north-east of the centre of its junction with Brangbourne Road.
 - 1 on the southbound approach to the existing pedestrian refuge island 15 metres northeast of the centre of its junction with Brangbourne Road. (iii)
 - 1 on the northbound approach to the existing pedestrian refuge island 13 (iv)
 - metres southwest of the centre of its junction with Brangbourne Road. 2 cushions, northeast of an existing refuge island, 56 metres southwest of the (v)
 - centre of its junction with Blacklands Road. (vi)
 - 2 across the carriageway, at an existing refuge island, 14 metres northeast of the centre of its junction with Dunfield Road.
 - (vii) 2 cushions, 1 on each approach to an existing refuge island, 111 metres and
 - 105 metres southwest of the centre of its junction with Dunfield Road.
 - (viii) 2 cushions, 1 on each approach to an existing refuge island, 14 metres and 21 metres northeast of the centre of its junction with the cycle track from
 - Sedgehill Road. 3 across the carriageway 21 metres northeast of the centre of its junction with
 - the northeast access road to Phoenix Sedgehill Village.
- (c) Five "round top" road humps in Blacklands Road, with a gap of between 200-
- 300mm at the kerb-lines or drainage channel. The road humps to be constructed with
- a round top sinusoidal profile over a length of 3.7 metres and height of 75mm (+/-5mm) at its highest point, with the centreline at the following locations:-
 - 17 metres south of the southern kerbline of Southend Lane (i)
 - 103 metres south of the southern kerbline of Southend Lane. (ii)
 - (iii) 29 metres northwest of the centre of Melfield Gardens.
 - 44 metres southeast of the centre of Melfield Gardens. (iv)
 - 11 metres northwest of the northwestern kerbline of Beckenham Hill Road. (v)
- (d) One road hump in Southend Lane known as a "speed table" across the entire
- carriageway width, with the centreline located 12 metres southwest of the centre of its
- junction with Allerford Road. The hump to be constructed with an elevated section of
- carriageway of 75mm (+/- 5mm) at its highest point with a flat top of a minimum of 6
- metres in length and ramps with a length of 1.5 metres.
- (e) Three "flat top" road humps in Southend Lane, with a gap of between 200-300mm
- at the kerb-lines or drainage channel. The road humps to be constructed with an elevated section of carriageway of 75mm (+/- 5mm) at its highest point with a flat top of a minimum of 6 metres in length and ramps with a length of 1.5 metres with the centreline
- at the following locations:-
 - In both east and westbound carriageways, 50 metres east of the centre of its
 - junction with Farmstead Road
 - In both east and westbound carriageways, 13 metres east of the centre of its

 - junction with Arnulf Street.
 - In both north-east and south-westbound carriageways, 22 metres northeast of the centre of its junction with Blacklands Road.
- (f) One road hump known as a "speed cushion" in Southend Lane in the westbound
- carriageway, with the centreline 43 metres west of the of the centre of its junction with
- Dunfield Road. The speed cushion to be constructed 75mm high (+/- 5mm), 2.5 metres
- long, 1.6 metres wide, on/off ramps 1:8, sides 1:4.
 (g) One "flat top" road hump in Whitefoot Lane, with a gap of between 200-300mm at the kerb-lines or drainage channel with the centreline located 39 metres east of the
- centre of its junction with Longhill Road. The road hump to be constructed with an
- elevated section of carriageway of 75mm (+/- 5mm) at its highest point with a flat top of a minimum of 6 metres in length and ramps with a length of 1.5 metres. (h) Road humps known as "speed cushions" in Whitefoot Lane. The speed cushions to be constructed 75mm high (+/- 5mm), 2.5 metres long, 1.7 metres wide, on/off ramps
- 1:8, sides 1:4, with the centreline at the following locations:-
 - 2 speed cushions westbound carriageway, 85 metres east of the centre of its junction with Conisborough Crescent.
 - (ii) 2 speed cushions westbound carriageway, 157 metres east of the centre of its
 - junction with Conisborough Crescent.
 - (iii) 2 speed cushions eastbound carriageway, 193 metres east of the centre of its junction with Conisborough Crescent.
 - 2 speed cushions eastbound carriageway, 29 metres east of the centre of its
- junction with Haddington Road.
 (B) To remove two existing "flat top" road humps in Whitefoot Lane, with the centreline
- located in the eastbound carriageway, 20 metres west of Downderry Road and in the westbound carriageway, 15 metres east of Longhill Road.
