ROAD TRAFFIC REGULATION ACT 1984

THE A2 GLA ROAD (EAST ROCHESTER WAY, LONDON BOROUGH OF BEXLEY) (TEMPORARY 30 MPH SPEED LIMIT AND PROHIBITION OF TRAFFIC AND STOPPING) ORDER 2019

1. Transport for London hereby gives notice that it intends to make the above named Traffic Order under section 14(1) of the Road Traffic Regulation Act 1984 for the purpose specified in paragraph 2. The effect of the Order is summarised in paragraph 3.
2. The purpose of the Order is to enable carriageway resurfacing works to take place at A2 East Rochester Way.
3. The effect of the Order will be to prohibit any vehicle from entering, exiting or proceeding on the:
 - (1) off-slip road connecting the eastbound carriageway of East Rochester Way with A221 Danson Road.
 - (2) on-slip road connecting Lodge Lane with the eastbound carriageway of East Rochester Way.
 - (3) off-slip road connecting the westbound carriageway of East Rochester Way with Blendon Road.
 - (4) on-slip road connecting Blendon Road with the westbound carriageway of East Rochester Way.

The Order also prohibits any vehicle from:

- (5) exceeding a speed of 30mph on the eastbound carriageway of East Rochester Way between the extended common boundary of Nos.34 and 35 Lakeside Close to the extended common boundary of Nos. 34 and 35 Penn Lane.
- (6) exceeding a speed of 30mph on the westbound carriageway of East Rochester Way between the extended western boundary line of No.34 Arcadian Avenue to the extended common boundary of Nos. 30 and 31 Park Mead.
- (7) stopping on Danson Road between its junctions with East Rochester Way off-slip and A221 Danson Road.

The Order will be effective from 9:00 PM on the 18th November 2019 until 6:00 AM on 31st March 2020 or when the works have been completed whichever is the sooner. The prohibition will apply only during such times and to such extent as shall from time to time be indicated by traffic signs.

4. The prohibitions will not apply in respect of:
 - (1) any vehicle being used for the purposes of those works or for fire brigade, ambulance or police purposes;
 - (2) anything done with the permission or at the direction of a police constable in uniform or a person authorised by Transport for London.
5. At such times as the prohibitions are in force alternative routes will be indicated by traffic signs via: **(for eastbound traffic on A2 East Rochester Way wishing to enter Danson Road)** East Rochester Way, Black Prince Interchange, A223 Bourne Road, A223 Southwold Road, East Rochester Way, Danson interchange, A221 Blendon Road, A221 Danson Underpass to roundabout to normal route of travel; **(for traffic on Lodge Lane wishing to enter East Rochester Way eastbound)** Danson Road, A207 Crook Log, A207 Broadway, A207 Albion Road, A220 Gravel Hill, East Rochester Way returning to normal route of travel; **(for westbound traffic on East Rochester Way wishing to enter Blendon Road)** - Falconwood junction, Riefield Road, Rochester Way, Welling Way, Bellegrove Road, A207 Welling High Street, A207 Park View Road, Danson Road, A221 Danson Underpass to normal route of travel; **(For Blendon Road to westbound A2 Rochester Way)** Blendon Road, Danson Underpass to Lodge Lane, East Rochester Way, Black Prince Interchange, Bourne Road, Southwold Road, East Rochester Way to normal route of travel.
