(KNOWN AS "SPEED TABLES" AND "RAISED ENTRY TREATMENTS") IN ACRE LANE, BAYTREE ROAD, BALLATER ROAD, BRANKSOME ROAD, CONCANON ROAD, CORRANCE ROAD, HETHERINGTON ROAD, PLATO ROAD AND STRATHLEVEN ROAD

This Notice is about proposals to provide road humps (known as "speed tables" and "raised entry

treatments") in the above roads. Objections or other comments may be made - see paragraph 5.] 1. NOTICE IS HEREBY GIVEN that the Council of the London

Borough of Lambeth proposes, under section 90A of the Highways Act 1980, to introduce:-(1) a road hump known as a "speed table" at the junction of

Acre Lane and Baytree Road (the road hump would extend along Acre Lane for a distance of 16 metres and into Baytree Road for a distance of 6 metres from Acre Lane - both

measurements include the ramps); and (2) road humps known as "raised entry treatments" in the following roads at their junction with Acre Lane (the length of each road hump, measured from Acre Lane and including the

- ramps, is specified in brackets):-(a) Ballater Road (6 metres): (b) Branksome Road (7.5 metres);
 - (c) Concanon Road (6 metres);
 - (d) Corrance Road (5 metres);
 - (e) Hetherington Road (6 metres);
 - (f) Plato Road (7 metres); and (q) Strathleven Road (6 metres).
- [A road hump known as a "speed table" or "raised entry treatment" is an elevated section of carriageway that is no more than 100 millimetres higher than the existing carriageway and which has a flat top that extends across the full width of the carriageway from kerb to kerb, so that the flat top of the speed table or raised entry treatment and the adjoining footways form a continuous surface.]
- 2. These changes are designed to reduce drivers' speeds when turning and reduce pedestrians' crossing distance. The measures will, in addition, provide a level surface for pedestrians crossing the side roads. To avoid riders of two wheelers losing control when turning into the side roads, the
