  - between Downton Avenue and Cricklade Avenue (alternative routes for affected vehicles will be available via Downton Avenue, Emsworth Street and Cricklade Avenue and vice versa); (e) at certain other times to temporarily ban vehicles from entering that length of Faygate Road which lies
  - between Cricklade Avenue and Amesbury Avenue (alternative routes for vehicles will be available via Cricklade Avenue, Emsworth Street and Amesbury Avenue and vice versa): (f) at certain other times to temporarily ban vehicles from entering that length of Faygate Road which lies between Amesbury Avenue and Lydhurst Avenue (alternative routes for affected vehicles will be available

via Amesbury Avenue and Hailsham Avenue and vice

(g) at certain times to temporarily ban vehicles from entering that length of Telford Avenue which lies between Thornton Avenue and that length which for the time being is GLA red route side road (alternative routes for affected vehicles will be available via Streatham Hill, Streatham Place New Park Road and Thornton Avenue and vice versa): (h) at certain other times to temporarily ban vehicles from

- entering that length of Telford Avenue which lies between Thornton Avenue and Rastell Avenue (alternative routes for affected vehicles will be available via Thornton Avenue, Emmanuel Road and Rastell Avenue and vice versa).
- 2. The road closures will only apply at such times and to such extent as shall be indicated by the placing of the appropriate
- traffic signs. 3. The Order will come into force on 27th February 2020 and will continue for a maximum duration of 1 month or until the

works have been completed whichever is the sooner.
