Objections may be

made - see paragraph 6.) 1. NOTICE IS HEREBY GIVEN that the Council of the London Borough of Lambeth propose to make the Lambeth (Kennington) (Parking Places) (No. **) Order 202* and the Lambeth (Waiting and Loading Restrictions) (Amendment No.

***) Order 202* under sections 6, 45, 46, 49 and 124 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984. The general effect of the Orders would be in Walcot Square on the north side of the east to west arm to:-

(a) reinstate a redundant vehicular crossover opposite No. 6 Walcot Square and extend the adjacent residents' parking place:

(b) remove a length of residents' parking place at the side of No. 9 Walcot Square and ban waiting at any time (indicated by double yellow lines) in that length

of road instead. 3. The proposed Orders are required to (a) remove a length of parking space adjacent to a dropped kerb (that is still to be constructed) so as to allow vehicular access to properties; and (b) provide new parking space where a dropped kerb is
