ROAD TRAFFIC REGULATION ACT 1984

THE A102 GLA SIDE ROAD (BLACKWALL TUNNEL APPROACH SLIP ROAD, ROYAL BOROUGH OF GREENWICH) (TEMPORARY PROHIBITION OF TRAFFIC) ORDER 2020

- 1. Transport for London having consulted the Royal Borough of Greenwich hereby gives notice that it has made the above named Traffic Order under section 14(1) of the Road Traffic Regulation Act 1984 for the purpose specified in paragraph 2. The effect of the Order is summarised in paragraph 3.
- 2. The purpose of the Order is to enable abnormal load transportation works to take place on or near the A102 Blackwall Tunnel Approach.
- 3. The effect of the Order will be to prohibit any:
- (I) vehicle from entering, exiting or proceeding on the unnamed slip road connecting the unnamed off-slip road connecting the southeastbound carriageway of the A102 Blackwall Tunnel Approach with Blackwall Lane with Millennium Way, hear after referred to as the Millennium Way slip-road;
 - (2) pedestrian or pedal cycle from proceeding on the footway at the north-western side of the Millennium Way slip-road; (3) pedestrian or pedal cycle from proceeding on the shared use footway at the south-western side of Millennium Way between its

junctions with the Millennium Way slip-road and the toucan

- pedestrian and cycle crossing across Millennium Way located approximately 50 metres south-east of its junction with Old School Close; (4) pedestrian or pedal cycle from proceeding on western footway of Blackwall Lane between a point 2 metres south of the extended
- northern building line of No. 210 Tunnel Avenue and the toucan pedestrian and cycle crossing across the Millennium Way slip-road. The Order also closes:
- (5) the toucan pedestrian and cycle crossing across the Millennium Way slip-road;
- (6) the traffic signal controlled crossing at the western side of Blackwall Lane across the on and off-slip roads to and from the A102 Blackwall Tunnel Approach.
- The Order will be effective at certain times between the dates of 15th February 2020 and 23rd February 2020 and between the dates of 7th March 2020 and 15th March 2020, every Saturday at 2:00 PM until Sunday at 11.59 AM or when the works have been completed whichever is the sooner. The prohibitions will apply only during such times and to such extent as shall from time to time be indicated by traffic signs.
- The prohibitions will not apply in respect of:
 - (I) any vehicle being used for the purposes of those works or for fire brigade, ambulance or police purposes; (2) anything done with the permission or at the direction of a police
- constable in uniform or a person authorised by Transport for London. 5. At such times as the prohibitions are in force alternative routes will be
- indicated by traffic signs via (for the closure of the Millennium Way slip road) Blackwall Lane to normal route of travel (for the closures of the footways and crossings), the signal controlled crossing across Blackwall Lane immediately south of its junction with Tunnel Avenue, the eastern footway of Blackwall Lane, southern footway of Bugsby's Way, The Toucan Crossing across Bugsby's Way outside the Holiday Inn Express, The northern footway Busby's Way, the south-eastern footway of John Harrison Way, the toucan crossing across Harrison Way outside Millennium primary School, the north-western footway of Harrison Way, the north-eastern footway of Millennium Way, the toucan crossing across Millennium Way at the rear of St Mary Magdalene C of E
