ROAD TRAFFIC REGULATION ACT 1984

THE A40 GLA ROAD AND A4202 GLA ROAD (CUMBERLAND GATE AND PARK LANE, CITY OF WESTMINSTER) (TEMPORARY PROHIBITION OF TRAFFIC AND STOPPING) ORDER 2020

1. Transport for London in consultation with City of Westminster hereby gives notice that it has made the above named Traffic Order under section 14(1) of the Road Traffic Regulation Act 1984 for the purpose specified in paragraph 2. The effect of the Order is summarised in paragraph 3.
2. The purpose of the Order is to enable road improvement works to take place at Cumberland Gates, Park Lane and Tyburn Way.
3. The effect of the Order will be to prohibit any vehicle from:
 - (1) entering, exiting or proceeding on A40 Cumberland Gate between its junctions with Park Lane and Bayswater Road;
 - (2) entering, exiting or proceeding on the southbound carriageway of A4202 Park Lane between its junctions with Marble Arch and Green Street;
 - (3) entering, exiting or proceeding on A40 Tyburn Way between its junctions with A40 Cumberland Gate and Marble Arch;
 - (4) entering, exiting or proceeding on the westbound carriageway of Oxford Street between its junctions with Park Street and Park Lane;
 - (5) entering, exiting or proceeding on North Carriage Drive at its junction with Cumberland Gate;
 - (6) entering or proceeding on the westbound carriageway of Bayswater Road between its junctions with Cumberland Gate and Stanhope Place;

This Order also prohibits any vehicle from:

- (7) stopping in the Loading and Unloading Bay outside No. 139 Park Lane (Marriott Hotel);
 - (8) stopping in the Diplomatic Cars only Bay outside No.140 Park Lane.
- The Order will be effective between 28th February 2020 and 31st March 2020 every night from 10:00 PM to 5:00 AM or when the works have been completed whichever is the sooner. The prohibition will apply only during such times and to such extent as shall from time to time be indicated by traffic signs.
4. The prohibitions will not apply in respect of:
 - (1) any vehicle being used for the purposes of those works or for fire brigade, ambulance or police purposes;
 - (2) anything done with the permission or at the direction of a police constable in uniform or a person authorised by Transport for London.
 5. At such times as the prohibitions are in force alternative routes will be indicated by traffic signs. For Bayswater Road via Edgware Road to Sussex Gardens to Westbourne Street to Bayswater Road to original route of travel. For Marble Arch via Bayswater Road to Lancaster Terrace to Sussex Gardens to Norfolk Place to Praed Street to Edgware Road to original route of travel. For Park Lane from Oxford Street - via North Audley Street, Grosvenor Square, Upper Grosvenor Street to original route of travel. For Park Lane from Marble Arch via Oxford Street to Portman Street to Portman Square to Orchard Street to the previous diversion route.
