 1. NOTICE IS HEREBY GIVEN that, to enable gas main replacement works to be carried out, the Council of London

 - Sancroft Street, Vauxhall Street and Kennington Lane);

- vehicles via Kennington Lane, Vauxhall Street, Sancroft Street and Newburn Street);
 (c) ban motor vehicles from entering that length of Vauxhall Street which lies between a point 120 metres south-east of Kennington Lane and a point 90 metres north-west of Kennington Oval (an alternative route
- north-west of Kennington Oval (an alternative route would be available for affected vehicles via Kennington Lane, Durham Street, Harleyford Road and Kennington Oval).

 2. Whenever the ban referred to in paragraph 1(b) above applies the Order that imposes the one-way system in
- Drowled that imposes the one-way system in Loughborough Street between Kennington Lane and Brangton Road would be suspended in so far as that Order bans vehicles proceeding in that length of Loughborough Street from travelling in a direction other than from southeast to north-west, to allow vehicular access and egress, provided it does not interfere with or disrupt the works.
- east to north-west, to allow vehicular access and egress, provided it does not interfere with or disrupt the works.

 3. Whenever the ban referred to in paragraph 1(c) above applies the Order that imposes the one-way system in that length of Vauxhall Street which lies between Kennington Lane and Kennington Oval would be suspended in so far as
- length of Vauxhall Street which lies between Kennington Lane and Kennington Oval would be suspended in so far as that Order bans vehicles proceeding in that length of Vauxhall Street from travelling in a direction other than from northwest to south-east, to allow vehicular access and egress, provided it does not interfere with or disrupt the works.

 4. The bans and suspensions would only apply at such times

and to such extent as shall be indicated by the placing of the appropriate traffic signs.

5. The order would come into force on 6th April 2020 and it would continue for a maximum duration of 6 months or until the works have been completed whichever is the earlier.
