ON-STREET AND OFF-STREET PARKING CHARGE CHANGES

The Lewisham (Charged-For Parking Places) (Amendment No. 36) Order 2020

The Lewisham (Off-Street) (Parking Places) (Amendment No. 4) Order 2020

1. NOTICE IS HEREBY GIVEN that Lewisham Borough Council on 27th March made the above-mentioned Orders under the powers of sections 6, 45, 46, 49 and 124 of and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984, as amended.

2. The general nature and effect of the Orders will be to:

(a) alter the charges payable, including for the purchase of permits and vouchers, for the use of on-street parking places and off-street parking places (Council-run car parks) so that they will be based on vehicle type and emissions produced or engine size as set out in the Schedule to this Notice; and

(b) make certain other clerical changes to the ‘parent’ Orders that the above Orders amend so that they reflect current permit provisions.

3. Documents giving more detailed particulars of the Orders can be inspected during normal office hours on Mondays to Fridays at the office of Lewisham Transport Policy & Development, 5th Floor Laurence House, 1 Catford Road, London SE6 4RU.

4. If any person wishes to question the validity of the Orders or of any of their provisions on the grounds that it or they are not within the powers conferred by the Road Traffic Regulation Act 1984, or that any requirement of that Act or of any instrument made under that Act has not been complied with, that person may, within 6 weeks from the date on which the Orders were made, apply for the purpose to the High Court.
