ROAD TRAFFIC REGULATION ACT 1984

THE A4 GLA ROAD (BROMPTON ROAD, ROYAL BOROUGH OF KENSINGTON & CHELSEA) (TEMPORARY PROHIBITION OF TRAFFIC AND STOPPING) ORDER 2020

1. Transport for London hereby gives notice that it intends to make the above named Traffic Order under section 14(1) of the Road Traffic Regulation Act 1984 for the purpose specified in paragraph 2. The effect of the Order is summarised in paragraph 3.
2. The purpose of the Order is to enable gas works to take place on A4 Brompton Road.
3. The effect of the Order will be to prohibit any vehicle from:
 - (1) turning right from A4 Brompton Road onto Hans Road
 - (2) turning right from Cottage Place onto A4 Brompton Road
 - (3) Stopping on A4 Brompton Road between its junctions with Cottage Place and Brompton Square
 - (4) Stopping in the loading and unloading only bay outside Nos. 219 to 225 A4 Brompton Road
 - (5) Stopping in the loading and unloading only bay outside Nos. 227 to 237 A4 Brompton Road
 - (6) Stopping in the loading and unloading only bay outside Nos. 112 to 124 A4 Brompton Road
 - (7) Stopping eastbound on A4 Brompton Road between its junction with Knightsbridge Green and Montpelier Street
 - (8) Stopping in the loading and unloading only bay outside Nos. 33 to 39 A4 Brompton Road

This Order also allows

- (9) All vehicles to use the eastbound bus lane on A4 Brompton Road between its junctions with Montpelier Street and Knightsbridge Green
- (10) All vehicles to use the eastbound bus lane on A4 Brompton Road between its junctions with Cottage Place and Brompton Square

Works will be phased such that not all restrictions may apply at any one time

The Order will be effective at certain times from 5:00 AM on 30th March 2020 until 11:59 PM on 7th September 2020 for articles 3(1) to 3(5) and 3(10). From 5:00 AM on 24th April 2020 until 11:59 PM on 21st August 2020 for articles 3(7) and 3(9). From 5:00 AM on 24th April 2020 until 11:59 PM on 10th August 2020 for article 3(6) and lastly from 5:00 AM on 4th May 2020 until 11:59 PM on 21st August 2020 or when the works have been completed, whichever is the sooner. The prohibition will apply only during such times and to such extent as shall from time to time be indicated by traffic signs.

4. The prohibitions will not apply in respect of:
 - (1) any vehicle being used for the purposes of those works or for fire brigade, ambulance or police purposes;
 - (2) anything done with the permission or at the direction of a police constable in uniform or a person authorised by Transport for London.
5. At such times as the prohibition is in force an alternative route will be indicated by traffic signs via:
 - (1) **[For Hans Road]** Brompton Road, Knightsbridge, Piccadilly, Duke of Wellington Place, Grosvenor Place, Knightsbridge, Brompton Road to normal route of travel
 - (2) **[For Westbound Brompton Road]** Brompton Road, Knightsbridge, Piccadilly, Duke of Wellington Place, Grosvenor Place, Knightsbridge, Brompton Road to normal route of travel
