## LONDON BOROUGH OF LEWISHAM Road Traffic Regulation Act 1984 The Lewisham (Various Roads) (Covid-19) (Phase 1b) (Temporary Prohibition of Traffic) Order 2020

## NOTICE IS HEREBY GIVEN that Lewisham Council made this temporary traffic order under the provisions of section 14(1) of the Road Traffic

Regulation Act 1984 as amended by The Traffic Orders Procedure (Coronavirus) (Amendment) (England) Regulations 2020 because of the likelihood of danger to the public on and adjacent to the highway, and that it was necessary to make the order for purposes connected to coronavirus so as to maintain social distancing on and adjacent to the highway at various locations, and in various roads. The order allows social distancing measures to be provided at various locations. The effects of the order are indicated below. 1. (1) Road closure for all vehicles except motorcycles in:- (i) Cambridge

- Drive adjacent to side of 133-136 Leybridge Court; (ii) Dallinger Road adjacent to 119 Dallinger Road (iii) Dermody Road 4 metres east of 66 & 68 Wisteria Road; (iv) Ennersdale Road, 12 metres northeast of Nightingale Grove; (v) Holme Lacey Road, adjacent to 217 Manor Lane; (vi) Leahurst Road, adiacent to 127/129 Ennersdale Road; (vii) Leyland Road, 58 metres north Carston Close; (viii) Manor Lane, adjacent to side of 13 Manor Lane; (ix) Manor Lane, 18 metres south of Fernbrook Road; (x) Manor Lane Terrace, adjacent to the side of 47 Kellerton; (xi) Manor Park, between 4 and 14 metres northwest of 42 Manor Park; (xii)Upwood Road, 7 metres east of 62 & 64 Upwood Road; and (xiii) Woodvates Road, 2 metres north of the Westhorne Avenue. (2) The diversion routes for traffic affected by the closures are via local neighbouring roads. No parking/waiting at any time in (i) Cambridge Drive both sides
- adjacent to side of 133-136 Leybridge Court; (ii) Dallinger Road, outside 108 & 119 Dallinger Road: (iii) Holme lacy Road, outside the side of 217 Manor Lane: (iv) Leyland Road, both sides for approximately 15 metres adjacent to the multi storey car park:(v) Manor Lane, both sides to side of 13 Manor Lane; (vi) Manor Lane Terrace side of 47 Kellerton Road: and (vii) Upwood Road, both sides, outside 62/62/66 Upwood Road,
- The current southbound one-way working in Pascoe Road is suspended and replaced by northbound one-way working. (Note: Cycles are excluded and are able to use Pascoe Road in both directions)
- Exemption is provided in the order for vehicles being used for ambulance, fire brigade or police purposes in an emergency and anything done with the permission or at the direction of a police officer in uniform.
- The order comes into force on the 20th July 2020 to remain in force for up to 18 months.
- 6. The prohibitions apply as, when and to the extent signed on the highway.
