- 2020): (b) Beardell Street, between Westow Hill and a point 20 metres north of Westow Hill
- (it is anticipated that the works would be carried out between 31st August and 4th September 2020); (c) Angles Road (the north-west to south-east arm), between the western kerb-line of the north to south arm of Angles Road and Nos. 31/33 Angles Road (it is
  - anticipated that the works would be carried out between 7th and 10th September 2020): (d) Casewick Road, between No. 151 Casewick Road and No. 161 Casewick Road (it
  - is anticipated that the works would be carried out between 8th and 11th September 2020); (e) Broxholm Road, between Glennie Road and No. 46 Broxholm Road (it is
  - anticipated that the works would be carried out between 14th and 17th September 2020).
- 2. Alternative routes for affected vehicles would be available as follows:-(a) for the closure of Greenhurst Road described in paragraph 1(a) above via
  - Lamberhurst Road and Cheviot Road and vice versa: (b) for the closure of Beardell Street described in paragraph 1(b) above via Westow Hill.
  - Jasper Road, Farguhar Road, Dulwich Wood Avenue, Colby Road, Gipsy Hill and Camden Hill Road:
  - (c) for the closure of Angles Road described in paragraph 1(c) above via Sunnyhill Road and Farm Avenue and vice versa:
  - (d) for the closure of Casewick Road described in paragraph 1(d) above via
  - Lamberhurst Road, Cheviot Road and Greenhurst Road and vice versa: (e) for the closure of Broxholm Road described in paragraph 1(e) above via Royal
- 3. The bans would only apply at such times and to such extent as shall be indicated by the placing of the appropriate traffic signs. 4. Whenever the ban referred to in paragraph 1(b) above applies in respect of Beardell Street the Order that imposes the one-way system in Beardell Street would be suspended.

5. The Order would come into force on 17th August 2020 and it would continue for a maximum duration of 3 months (to allow for contingences) or until the works have been completed whichever is the sooner. In practice it is anticipated that the Order would only have effect at one of the locations specified in paragraph 1 of this Notice at a time, and during the times specified in brackets next to each of those locations, but if the works cannot be carried out or completed during those times, then the Order may have effect at other times within the maximum duration of 3 months
