the Lambeth (Camberwell) (Parking Places) (No. 2) Order 2020 and the Lambeth (Waiting and Loading Restriction) (Amendment No. 291) Order 2020, under sections 6, 45, 46. 49 and 124 of and Part IV of Schedule 9 to the Road

Traffic Regulation Act 1984.

2. The general effect of the Orders would be to remove 10 metres of shared-use residents/business/pay by phone parking space in Gordon Grove, outside the entrance to Elam Street Open Space, and replace it with double yellow

- lines (where double yellow lines are placed on a road it indicates that vehicles are banned from waiting at any time). 3. The removal of parking space in Gordon Grove is to enable the kerb to be extended outside the entrance to the
- Elam Street Open Space as part of a redesign of the levels/drainage system which is intended to resolve an existing issue with flooding at the entrance and improve access to the park.
