

# Transport for London Notice

## ROAD TRAFFIC REGULATION ACT 1984

### THE A5 AND A404 GLA ROADS (EDGWARE ROAD AND HARROW ROAD, CITY OF WESTMINSTER) (TEMPORARY PROHIBITION OF TRAFFIC AND STOPPING) ORDER 2020

1. Transport for London in consultation with the City of Westminster hereby gives notice that it intends to make the above named Traffic Order under section 14(1) of the Road Traffic Regulation Act 1984 for the purpose specified in paragraph 2. The effect of the Order is summarised in paragraph 3.
2. The purpose of the Order is to enable resurfacing works to take place on Edgware Road and Harrow Road.
3. The effect of the Order will be to prohibit any vehicle from:
  - (1) entering, exiting, stopping, or proceeding in a westbound direction on Harrow Road between the westbound exit slip road from Marylebone Flyover north of Transept Street and the westbound exit slip road from Marylebone Flyover north of North Wharf Road;
  - (2) entering, exiting, stopping, or proceeding in an eastbound direction on Harrow Road between the eastbound entry slip road to Marylebone Flyover at Paddington Green and the eastern extent of the eastbound entry slip road to Marylebone Flyover at Lisson Street;
  - (3) entering, exiting, stopping or proceeding on Edgware Road between Broadley Street and Bayswater Road;
  - (4) entering, exiting or proceeding on George Street between Brown Street and Edgware Road;
  - (5) entering, exiting or proceeding on Kendal Street between Portsea Place and Edgware Road;
  - (6) entering, exiting or proceeding on Seymour Street between Great Cumberland Place and Connaught Street;
  - (7) entering, exiting or proceeding on Old Marylebone Road between Cabbell Street and Edgware Road; and
  - (8) entering, exiting or proceeding on Sussex Gardens between Sale Place and Edgware Road.

The Order will be effective at certain times from 10:00 PM on the 19th September 2020 until 5:00 AM on the 31st December 2020 every night 10:00 PM to 5:00 AM or when the works have been completed whichever is the sooner. The prohibitions will apply only during such times and to such extent as shall from time to time be indicated by traffic signs.

4. The prohibitions will not apply in respect of:
  - (1) any vehicle being used for the purposes of those works or for fire brigade, ambulance or police purposes;
  - (2) anything done with the permission or at the direction of a police constable in uniform or a person authorised by Transport for London.
5. At such times as the prohibitions are in force alternative routes will be indicated by traffic signs for:
  - (1) Edgware Road northbound via Marylebone Road, Gloucester Place, Park Road, St John's Wood Road to normal route of travel;
  - (2) Edgware Road southbound via Marylebone Road, Baker Street, Portman Square, Seymour Street to normal route of travel;
  - (3) Edgware Road northbound via Marble Arch, Cumberland Gate, Bayswater Road, Lancaster Terrace, Sussex Gardens to normal route of travel;
  - (4) Edgware Road southbound via Sussex Gardens, Westbourne Street, Bayswater Road to normal route of travel;
  - (5) Harrow Road via Edgware Road, Old Marylebone Road, Marylebone Road Harrow Road or reverse and return to normal route of travel.
