ROAD TRAFFIC REGULATION ACT 1984

THE A40 GLA ROAD AND A4202 GLA ROAD (CUMBERLAND GATE AND PARK LANE, CITY OF WESTMINSTER) (TEMPORARY

PROHIBITION OF TRAFFIC AND STOPPING) (No.2) ORDER 2020

- I. Transport for London in consultation with the City of Westminster hereby gives notice that it has made the above named Traffic Order under section 14(1) of the Road Traffic Regulation Act 1984 for the purpose specified in paragraph 2. The effect of the Order is summarised in paragraph 3.
- 2. The purpose of the Order is to enable resurfacing works to take place on Cumberland Gate.
- 3. The effect of the Order will be to prohibit any vehicle from:(1) entering or proceeding on Bayswater Road westbound between its
 - junctions with Cumberland Gate and Stanhope Place;
 (2) entering, proceeding or stopping on Oxford Street westbound
 - between its junctions with Park Street and Park Lane;
 (3) entering, proceeding or stopping on Park Lane between its junctions with Oxford Street and Green Street;
 - (4) entering, exiting or proceeding on North Carriage Drive between its junctions with West Carriage Drive and Cumberland Gate, access will be maintain to the car park;
 - (5) entering North Row between its junctions with Park Lane and Dunraven Street, access will be maintained.

The Order will also reverse the southbound only one way operation on Dunraven Street between its junctions North Row and Green Street to northbound only.

The Order will be effective at certain times from 12:01 AM on the 10th October 2020 until 6:00 AM on the 5th April 2021 every night 10:00 PM to 6:00 AM or when the works have been completed whichever is the sooner. The prohibitions will apply only during such times and to such extent as shall from time to time be indicated by traffic signs.

- 4. The prohibitions will not apply in respect of:
 - any vehicle being used for the purposes of those works or for fire brigade, ambulance or police purposes or used in connection with the Bank Station Upgrade project and vehicles associated with the cleaning of the carriageway;
 - (2) anything done with the permission or at the direction of a police constable in uniform or a person authorised by Transport for London.
- 5. At such times as the prohibitions are in force alternative routes will be indicated by traffic signs. For Bayswater Road via Edgware Road, Sussex Gardens and Westbourne Street to normal route of travel. For Park Lane southbound via Oxford Street, Portman Street, Portman Square, Orchard Street, North Audley Street, Grosvenor Square and Upper Grosvenor Street to normal route of travel.
