ROAD TRAFFIC REGULATION ACT 1984

THE A205 AND A212 GLA ROADS (STANSTEAD ROAD, CATFORD ROAD AND CATFORD HILL, LONDON BOROUGH OF LEWISHAM) (TEMPORARY PROHIBITION OF TRAFFIC AND STOPPING) ORDER 2020

1. Transport for London hereby gives notice that it has made the above named Traffic Order under section 14(1) of the Road Traffic Regulation Act 1984 for the purpose specified in paragraph 2. The effect of the Order is summarised in paragraph 3.
2. The purpose of the Order is to enable resurfacing works to take place on Stanstead Road, Catford Road and Catford Hill.
3. The effect of the Order will be to prohibit any vehicle from:
 - 1) entering or exiting Stanstead Road between its junctions with Rathfern Road and Catford Hill;
 - 2) entering, exiting, proceeding or stopping on Unnamed Service Road between Stanstead Road and Catford Hill. Local access will be maintained;
 - 3) entering, exiting, proceeding or stopping on Catford Hill/Catford Road between Unnamed Service Road and Rushey Green. Local access will be maintained;
 - 4) stop in the Loading and Unloading bay outside No. 27 Catford Hill;
 - 5) stop in the Loading and Unloading bay outside Nos. 29-31 Catford Hill;
 - 6) stop in the Parking and Disabled Persons vehicle's only bay adjacent to No. 36 Catford Hill but sited on the unnamed service road connecting Catford Hill with Stanstead Road;

This Order will also:

- 7) allow all vehicles to use the bus lanes on Stanstead Road/Catford Road between its junctions with Rathfern Road and Rushey Green;

The Order will be effective at certain times between 23rd October 2020 and 5th November 2020 every night from 9:00 PM to 5:00 AM (ceasing at 5:00 AM on 5th November 2020) or when the works have been completed whichever is the sooner. The prohibition will apply only during such times and to such extent as shall from time to time be indicated by traffic signs.

4. The prohibitions will not apply in respect of:
 - (1) any vehicle being used for the purposes of those works or for fire brigade, ambulance or police purposes;
 - (2) anything done with the permission or at the direction of a police constable in uniform or a person authorised by Transport for London.

At such times as the prohibitions are in force alternative routes will be indicated by traffic signs: **For Catford Hill from Rushey Green** via Bromley Road, Southend Lane, Stanton Way, Sydenham Road and Perry Hill to normal route of travel. **For Stanstead Road from Rushey Green** join the previous diversion route at Perry Hill, Perry Rise, Perry Vale, WalDRAM Park Road and Sunderland Road to normal route of travel. **For Rushey Green from Stanstead Road** via Sunderland Road, WalDRAM Park Road, Perry Vale, Perry Rise, Perry Hill, Sydenham Road, Stanton Way, Southend Lane and Bromley Road to normal route of travel. **For Rushey Green from Catford Hill** via Perry Hill, Sydenham Road, Stanton Way, Southend Lane and Bromley Road to normal route of travel. **For Rushey Green from Stanstead Road** via Brockley Rise, Stondon Park, Brockley Road, Adelaide Avenue, Ladywell Road and Lewisham High Street to normal route of travel. **For Stanstead Road from Rushey Green** via Lewisham High Street, Ladywell Road, Adelaide Avenue, Brockley Road, Stondon Park and Brockley Rise to normal route of travel.
