Exceptions from the provisions in articles 1 and 2 shall be provided for vehicles being used in connection with the removal of any obstruction to traffic; the maintenance, improvement, reconstruction, cleansing or lighting within the street; the laying, erection, alteration in or adjacent to the street of any sewer or of any main, pipe or apparatus for the supply

Exceptions from the provisions in articles 1, 2 and 3 shall be provided in the Order for any vehicle, on any occasion, when it is being used for fire brigade, ambulance or police purposes if the observance of those provisions would hinder the use of the vehicle; or anything done with the permission or at the direction of a police officer in uniform.

No parking or loading at any time in: - (i) Thorpewood Avenue, south side, between a point 8.0 metres east of Nos. 48/50 and Radlet Avenue; and (ii) Radlet Avenue, west side, between Thorpewood Avenue and a point
