1. (1) Article 2(iii) of The Lewisham (Various Roads)(Covid-19)(Phase 1) (Temporary Prohibition of Traffic) Order 2020 shall be revoked; and (2) Article 6(ii) in The Lewisham (Various Roads)(Covid-19)(Phase 1c) (Temporary Prohibition of Traffic) Order 2020 shall be revoked and

- Article 6(ii) in The Lewisham (Vanous Roads)(Covid-19)(Phase 1c)
 (Temporary Prohibition of Traffic) Order 2020 shall be revoked and
 replaced by article 2 of this Notice

 2. Except as provided in articles 4, 5, 6 and 7 of this order no person shall
 cause or permit any motor vehicle, to enter or proceed north-westward
- Ze Except as provided in a fuces 4, 3, 6 and 70 tims often in persons and cause or permit any motor vehicle, to enter or proceed north-westward in Leahurst Road, between a point 7.0 metres southeast of the projected common boundary of Nos. 127/129 Leahurst Road and a point of 6.5 metres north-westwards of that point.
- 3. Except as provided in articles 4, 5 and 6 of this order no person shall cause or permit any goods vehicle, having a maximum gross weight in excess of 7.5 tonnes, to enter or proceed in (i) Leahurst road, SE13, between a point 7.0 metres southeast of the projected common boundary of Nos. 127/129 Leahurst Road and a point of 6.5 metres north-westwards of that point, and (ii) George Lane between a point 2 metres east of the projected boundary of Nos. 173/175 George Lane and a point 5 metres west of the projected boundary of Nos. 176/177 George Lane
- 4. Exceptions from the provisions in articles 2 and 3 are provided in the Order for any vehicle, on any occasion, when it is being used for fire brigade, ambulance or police purposes if the observance of those provisions would hinder the use of the vehicle; or anything done with the permission or at the direction of a police officer in uniform.
 5. Exceptions from the provisions in articles 2 and 3 are provided for vehicles being used in connection with the removal of any obstruction
- to traffic; the maintenance, improvement, reconstruction, cleansing or lighting within the street; the laying, erection, alteration in or adjacent to the street of any sewer or of any main, pipe or apparatus for the supply of gas, water or electricity, or of any electronic communications network [within the meaning of the Communications Act 2003], or the placing, maintenance or removal of any traffic sign in the street.

 6. Exceptions from the provisions in article 2 and 3 are provided in the Order for (i) vehicles on the London Borough of Lewisham approved list in whiches (ii) refuse called the vehicles cannot be refused in a first procedule to a vehicle or cannot in refuse called the vehicles.
- 6. Exceptions from the provisions in article 2 and 3 are provided in the Order for (i) vehicles on the London Borough of Lewisham approved list of vehicles; (ii) refuse collection vehicles engaged in refuse collection; and (iii) any street cleansing vehicle whilst carrying out cleansing operations.
 7. Exceptions from the provisions in article 2 are provided in the Order for pedal cycles.
- 8. The order comes into force on the 4th day of January 2020 to remain in force for up to 18 months.
- 9. The prohibitions apply as, when and to the extent signed on the highway.
