ROAD TRAFFIC REGULATION ACT 1984

THE A3 AND A24 GLA ROADS (BALHAM HIGH ROAD, UPPER TOOTING ROAD, TOOTING HIGH STREET, HIGH STREET COLLIER'S WOOD AND PRIORY ROAD, LONDON BOROUGH OF LAMBETH, WANDSWORTH AND MERTON) (TEMPORARY PROHIBITION OF TRAFFIC) ORDER 2021

1. Transport for London hereby gives notice that it has made the above named Traffic Order under section 14(1) of the Road Traffic Regulation Act 1984 for the purpose specified in paragraph 2. The effect of the Order is summarised in paragraph 3.
2. The purpose of the Order is to enable resurfacing works to take place on Balham High Road, Upper Tooting Road, Tooting High Street, and High Street Colliers Wood.
3. The effect of the Order will be to prohibit any vehicle from:
 - (1) entering or exiting Balham High Road at its junctions with the following roads: Dinsmore Road, Balham New Road, Ravenswood Road, Oldridge Road, Rinaldo Road;
 - (2) entering or exiting Upper Tooting Road at its junctions with the following roads: Mandrake Road, Topsham Road, Beechcroft Road, Hebden Road, Letchworth Street, Hereward Road;
 - (3) entering or exiting Tooting High Street at its junction with Aldis Street;
 - (4) entering or exiting High Street Colliers wood at its junction with Walpole Road;
 - (5) entering Priory Road from Merton High Street;
 - (6) entering Priory Road from High Street Colliers Wood;
 - (7) entering or exiting Clapham Road at its junctions with the following roads: Mayflower Road, Stirling Road, Houghton Square (local access to be controlled by traffic marshal).

This Order will also:

Allow all vehicles to use the bus lanes on Balham High Road, Upper Tooting Road, Tooting High Street, High Street Colliers Wood and Clapham Road to the extent indicated by local signage.

Works will be phased such that not all restrictions may apply at any one time.

The Order will be effective at certain times between 22nd January 2021 and 31st March 2021, every night from 9:00 PM to 5:00 AM or when the works have been completed, whichever is the sooner. The prohibition will apply only during such times and to such extent as shall from time to time be indicated by traffic signs.

4. The prohibitions will not apply in respect of:
 - (1) any vehicle being used for the purposes of those works or for fire brigade, ambulance or police purposes;
 - (2) anything done with the permission or at the direction of a police constable in uniform or a person authorised by Transport for London.
5. At such times as the prohibition is in force an alternative route will be indicated by traffic signs via: For banned turn at Priory Road via Colliers Wood High Street, Mitcham Road, London Road, Holborn Way, Western Road and Christchurch Road to normal route of travel OR Merton High Street, Morden Road, Merantun Way and Christchurch Road to normal route of travel
