ROAD TRAFFIC REGULATION ACT 1984

THE A202 GLA ROAD (PECKHAM HIGH STREET, LONDON BOROUGH OF SOUTHWARK) (TEMPORARY PROHIBITION OF TRAFFIC AND STOPPING) ORDER 2021

1. Transport for London in consultation with the London Borough of Southwark hereby gives notice that it intends to make the above named Traffic Order under section 14(1) of the Road Traffic Regulation Act 1984 for the purpose specified in paragraph 2. The effect of the Order is summarised in paragraph 3.
2. The purpose of the Order is to enable highway improvement and resurfacing works to take place on the A202 Peckham High Street.
3. The effect of the Order will be to prohibit any vehicle from:
 - (1) entering, exiting, proceeding or stopping on Peckham High Street between its junction with Peckham Hill Street and a point 20m west of Sumner Avenue;
 - (2) entering or proceeding on the A202 Camberwell Church Street/ Peckham Road/ Peckham High Street eastbound between its junction with Camberwell Road and a point 20 metres west of Sumner Avenue, except for local access;
 - (3) entering or proceeding on the A202 Queen's Road/ Peckham High Street westbound between its junctions with New Cross Road and Peckham Hill Street, except for local access;
 - (4) entering, proceeding or stopping on Rye Lane between its junctions with Hanover Park and Peckham High Street;
 - (5) stopping in the Loading bay on Sumner Road on the side of No.27 Peckham High Street.

Works will be phased such that some restrictions will apply only at certain times.

The Order will be effective at certain times between 12:01 AM on 25th January 2021 until 11:59 PM on 31st May 2021 or when the works have been completed whichever is the sooner. The prohibitions will apply only during such times and to such extent as shall from time to time be indicated by traffic signs.

4. The prohibitions will not apply in respect of:
 - (1) any vehicle being used for the purposes of those works or for fire brigade, ambulance or police purposes;
 - (2) anything done with the permission or at the direction of a police constable in uniform or a person authorised by Transport for London.
5. At such times as the prohibitions are in force an alternative route will be indicated by traffic signs via Camberwell Road, Walworth Road, Newington Butts, Elephant and Castle, New Kent Road, Old Kent Road, New Cross Road or reverse to normal route of travel.
