ROAD TRAFFIC REGULATION ACT 1984

THE A3220 GLA ROAD (LATCHMERE ROAD, LONDON BOROUGH OF WANDSWORTH) (TEMPORARY PROHIBITION OF TRAFFIC) ORDER 2021

1. Transport for London hereby gives notice that it has made the above named Traffic Order under section 14(1) of the Road Traffic Regulation Act 1984 for the purpose specified in paragraph 2. The effect of the Order is summarised in paragraph 3.
2. The purpose of the Order is to allow a bridge inspection works to take place on Latchmere Road
3. The effect of the Order will be to prohibit any vehicle from;
 - (1) entering, exiting or proceeding on Elspeth Road between its junctions with Lavender Hill and Mysore Road. Local access will be maintained between Mysore Road and outside number 13;
 - (2) entering, exiting or proceeding on Latchmere Road between its junctions with Lavender Hill and Kathleen Road. Local access will be maintained between Kathleen Road and outside number 217;
 - (3) stopping on Elspeth Road between the junction of Lavender Hill and outside and opposite number 13;
 - (4) stopping on Latchmere Road between the junction of Lavender Hill and outside and opposite number 217;
 - (5) entering or exiting Kathleen Road at its junction with Lavender Hill;
 - (6) entering or exiting Theatre Street at its junction with Lavender Hill;
 - (7) entering or exiting Townhall Road at its junction with Lavender Hill;
 - (8) entering or exiting Lavender Gardens at its junction with Lavender Hill;
 - (9) exiting Mysore Road at its junction with Lavender Hill;
 - (10) turning left from Lavender Hill onto Elspeth Road;
 - (11) turning right from Lavender Hill onto Latchmere Road;
 - (12) turning right from Lavender Hill onto Elspeth Road;
 - (13) turning left from Latchmere Road onto Lavender Hill;
 - (14) turning left from Theatre Street onto Lavender HillThe Order will be effective at certain times from 8:00 AM on 8th March 2021 until 10:00 PM on July 31st 2021 or when the works have been completed, whichever is the sooner. The prohibitions will apply only during such times and to such extent as shall from time to time be indicated by traffic signs.
4. The prohibitions will not apply in respect of:
 - (1) any vehicle being used for the purposes of those works or for fire brigade, ambulance or police purposes;
 - (2) anything done with the permission or at the direction of a police constable in uniform or a person authorised by Transport for London.
5. At such times as the prohibitions are in force alternative routes will be indicated by traffic signs via A3036 Lavender Hill, A3036 St. John's Hill, A3 Marcilly Road, A3 North Side Wandsworth Common, A3 Battersea Rise, A205 Clapham Common West Side, A205 The Avenue, A3 Clapham North Side, A3216 Cedars Road, A3216 Queenstown Road, A3205 Battersea Park Road, Plough Road, A3205 York Road, Falcon Road, A3220 Battersea Bridge Road, A3220 Prince Of Wales Drive, A3220 Albert Bridge Road to normal route of traffic.
