THE A205 GLA ROADS (WESTHORNE AVENUE AND ROCHESTER WAY, ROYAL BOROUGH OF GREENWICH) (TEMPORARY PROHIBITION OF TRAFFIC AND STOPPING) ORDER 2021

- I. Transport for London in consultation with the Royal Borough of Greenwich hereby gives notice that it has made the above named Traffic Order under section 14(1) of the Road Traffic Regulation Act 1984 for the purpose specified in paragraph 2. The effect of the Order is
- 2. The purpose of the Order is to enable resurfacing works to take place on Westhorne Avenue and Rochester Way.
- 3. The effect of the Order will be to prohibit any vehicle from:
- (I) entering, exiting or proceeding on Rochester Way between its junctions with Westmount Road and Well Hall Roundabout, local access will be maintained between Westmount Road and Congreve Road:
 - (2) entering, exiting or proceeding on Rochester Way eastbound between its junctions with Kidbrooke Park Road and Well Hall Road. local access will be maintained between Kidbrooke Park Road and
 - Westhorne Avenue; (3) entering, exiting or proceeding on Rochester Way westbound
 - between its junctions with Well Hall Road and Westhorne Avenue; (4) entering, exiting, proceeding or stopping on Westhorne Avenue southbound between its junctions with Rochester Way/Well Hall
 - Road and Yorkshire Grey Roundabout; (5) entering, exiting, proceeding or stopping on Westhorne Avenue northbound between its junctions with Yorkshire Grey Roundabout
 - (6) entering or proceeding on the gyratory at the junction of Well Hall Road/Westhorne Avenue and Rochester Way; (7) entering or proceeding on the eastbound off-slip from Westhorne

and Rochester Way/Well Hall Road;

- Avenue to Rochester Way Relief Road; (8) entering or proceeding on the westbound on-slip from Westhorne Avenue to Rochester Way Relief Road;
- (9) entering or proceeding on the westbound on-slip from Rochester ${\bf r}$ Way Relief Road and Westhorne Avenue;
- (10) entering or proceeding on the eastbound off-slip from Rochester Way Relief Road to Westhorne Avenue; (11) entering or proceeding on the gyratory at the junction of Westhorne
- Avenue and the A2 Slip roads;
- (12) stopping on the south kerbline of Kidbrooke Lane between Westhorne Avenue and Well Hall Road;
- This Order will also permit two-way operation on Tudor Parade between its junctions with Westhorne Avenue and Well Hall Road. Works will be phased such that not all restrictions will apply at any one

closure of Rochester way is in force. Gate will be manned and under control with two-way lights. The fire gate on Kidbrooke Lane to be opened and manned while resurfacing works are taking place that require Kidbrooke Lane to be used as a local diversion.

The fire gate on Westmount Road to be used on diversion route when

The Order will be effective at certain times from 8:00 PM on 23rd May 2021 and 5:00 AM on 31st August 2021 every night 8:00 PM and 5:00 AM or when the works have been completed whichever is the sooner.

The prohibitions will apply only during such times and to such extent as shall from time to time be indicated by traffic signs. 4. The prohibitions will not apply in respect of:

- (I) any vehicle being used for the purposes of those works or for fire
- brigade, ambulance or police purposes; (2) anything done with the permission or at the direction of a police
 - constable in uniform or a person authorised by Transport for London.
- 5. At such times as the prohibitions are in force alternative routes will be indicated by traffic signs: For Rochester/Congreve closure via Westmount Road and Well Hall Road or reverse to normal route of travel; For Rochester eastbound closure via Kidbrooke Park Road, Eltham Road, Eltham Hill and Well Hall Road or reverse to normal route of travel, or via A2 northbound, Shooters Hill Road and Well Hall Road to normal route of travel; For Rochester westbound closure via Well Hall Road, Shooters Hill Road and A2 southbound to normal route of travel or via Well Road, Eltham Hill and Westhorne Avenue to normal route of travel; For Westhorne Avenue Closures via Well Hall Road and Eltham Hill or via Rochester Way, Kidbrooke Park Road and Eltham Road or reverse to normal route of travel; For A2 Slip closures to Westhorne Avenue via A2 westbound, Shooters Hill Road and Well Hall Road or via A2 eastbound, Well Hall Road and Eltham Hill to
