NOTICE IS HEREBY GIVEN that, to enable works to upgrade telecommunications equipment to be carried out, the Council of the London Borough of Lambeth have made an Order the effect of which will be to temporarily:-(i) ban vehicles from entering that length of RAEBURN STREET which lies between

    - (ii) between Corrance Road and Ballater Road in a westbound direction
      - (towards Corrance Road);
    - (i) Solon Road
      - (i) between Acre Lane and Keplar Road in a south-westward direction
      - (towards Acre Lane); (ii) between Keplar Road and Sandmere Road in a south-westward
    - (k) Tremadoc Road
      - (i) between Bedford Road and Kendoa Road in a easterly direction
      - (ii) between Kendoa Road and Kenwyn Road in a south-eastward direction
      - (iii) between Kenwyn Road and Clapham High Street in a south-eastward
- (iii) ban vehicles proceeding in:
  - (a) Acre Lane, entering:
    - (i) Ballater Road (an alternative route for affected vehicles will be available
    - via Acre Lane, Corrance Road and Raeburn Street); (ii) Corrance Road (an alternative route for affected vehicles will be available via Acre Lane, Ballater Road and Raeburn Street);
    - (iii) Solon Road (an alternative route for affected vehicles will be available

    - via Acre Lane, via Acre Lane, Corrance Road and Sandmere Road);
  - (b) Bedford Road, entering Tremadoc Road (an alternative route for affected vehicles will be available via Bedford Road, Lendal Terrace, Clapham High
    - Street and Tremadoc Road);
  - (c) Clapham High Street, entering: Cato Road (an alternative route for affected vehicles will be available
  - (d) Corrance Road, from turning right into Sandmere Road;
  - Kenwyn Road, from turning left into Tremadoc Road; Kendoa Road, from turning right into Tremadoc Road;
  - (g) Kepler Road, from turning left into Solon Road; (h) Raeburn Street, from turning right into Corrance Road; Raeburn Street, from turning right into Ballater Road and at other times from (i)
  - turning left into Ballater Road; Solon Road, entering Kepler Road (an alternative route for affected vehicles (i)
  - will be available via Solon Road, Acre Lane and Plato Road); (k) Solon Road, from turning right into Sandmere Road;
  - Tremadoc Road, entering Kenwyn Road (an alternative route for affected vehicles will be be available via Clapham High Street and St Luke's Avenue).
- 2. The one-way systems and bans described above will only apply at such times and to
- such extent as shall be indicated by the placing of the appropriate traffic signs. 3. Alternative routes for vehicles affected by the one-way traffic systems referred in sub-
- paragraph 1(ii) above will be available via adjacent roads as indicated by traffic signs.
- 4. The Order will come into force on 28th August 2021 and will continue for a maximum duration of 18 months or until the works have been completed, whichever is the sooner.
- systems will only apply in phases as the works progress along the roads concerned and it is anticipated that the works would take between 2 and 4 weeks to complete in each road. Dated 20th August 2021
