

# Transport for London Notice

## ROAD TRAFFIC REGULATION ACT 1984

### THE A40 GLA ROAD (WESTWAY FLYOVER, LONDON BOROUGH OF HAMMERSMITH AND FULHAM, ROYAL BOROUGH OF KENSINGTON AND CHELSEA AND CITY OF WESTMINSTER) (TEMPORARY PROHIBITION OF TRAFFIC AND STOPPING) ORDER 2021

1. Transport for London in consultation with the Royal Borough of Kensington and Chelsea hereby gives notice that it intends to make the above named Traffic Order under section 14(1), (5), (7) and 15(2) of the Road Traffic Regulation Act 1984 and is satisfied that these works will last in excess of 18 months for the purpose specified in paragraph 2. The effect of the Order is summarised in paragraph 3.
2. The purpose of the Order enable expansion joint repair works to take place on the A40 Westway.
3. The effect of the Order will be to prohibit any vehicle from:
  - (1) entering, exiting, proceeding or stopping on the A40 Westway/ Marylebone Flyover between its junctions with eastbound off-slip to West Cross Route/Westway Roundabout and Old Marylebone Road;
  - (2) entering or proceeding on the eastbound on-slip between Westway Roundabout and Westway;
  - (3) entering or proceeding on the eastbound on-slip between Harrow Road and Marylebone Flyover;
  - (4) entering or proceeding on the westbound on-slip between Gloucester Terrace and Westway;
  - (5) entering, exiting, proceeding or stopping on Acklam Road between its junctions with Blagrove Road and Nos. 147 to 181 and Nos. 183 to 185 Acklam Road;
  - (6) entering or proceeding on Bevington Road, St Ervans and Blagrove Road between Golborne Road and Acklam Road, local access will be maintained;
  - (7) entering or proceeding on Acklam Road between its junction with St Ervans Road and Nos. 147 to 181 and Nos. 183 to 185 Acklam Road, local access will be maintained;

The Order will also suspend the:

- (8) the footway fronting Acklam Road between its junctions with Blagrove Road and Nos. 147 to 181 and Nos. 183 to 185 Acklam Road;
- (9) traffic gate on Warwick Gardens southbound between its junctions with High Street Kensington and Pembroke Road to facilitate diverted traffic as a contingency and only during such times as indicated by traffic signs.

The Order will be effective at certain times from 7.00 AM on the 13th September 2021 until the works have been completed. The prohibitions will apply only during such times and to such extent as shall from time to time be indicated by traffic signs.

4. The prohibitions will not apply in respect of:
  - (1) any vehicle being used for the purposes of those works or for fire brigade, ambulance or police purposes;
  - (2) anything done with the permission or at the direction of a police constable in uniform or a person authorised by Transport for London.
5. At such times as the prohibitions are in force alternative routes will be indicated by traffic signs. **Westbound Diversion** via Old Marylebone Road, Edgware Road, Marble Arch, Park Lane, Hyde Park Corner, Knightsbridge, Brompton Road, Thurloe Place, Cromwell Gardens, Cromwell Road, West Cromwell Road, Warwick Road, Holland Road, Elsham Terrace, Holland Road, Holland Park Roundabout, West Cross Route and Westway Roundabout to normal route of travel. **Eastbound Diversion** via the eastbound off-slip to West Cross Route/Westway Roundabout, Westway Roundabout, West Cross Route, Holland Park Roundabout, Holland Road, Addison Crescent, Addison Road, Warwick Gardens, Pembroke Road, Earls Court Road, Cromwell Road, Cromwell Gardens, Thurloe Place, Brompton Road, Knightsbridge, Hyde Park Corner, Park Lane, Marble Arch, Edgware Road, Harrow Road westbound, Harrow Road Roundabout and Harrow Road eastbound to normal route of travel. **Local Eastbound diversion** via the eastbound off-slip to West Cross Route/Westway Roundabout, Westway Roundabout, West Cross Route, Holland Park Roundabout, Holland Park Avenue, Notting Hill Gate, Pembridge Road, Pembridge Villas, Westbourne Grove, Bishop's Bridge Road and Harrow Road or reverse to normal route of travel. For **Acklam Road diversion** via Blagrove Road, Bevington Road, Golborne Road and St Ervans Road or reverse to normal route of travel.
6. The Order will be revoked upon completion of these works.
