ROAD TRAFFIC REGULATION ACT 1984

THE A3220 GLA ROAD (CREMORNE ROAD, EDITH GROVE, ROYAL BOROUGH OF KENSINGTON AND CHELSEA) (TEMPORARY PROHIBITION OF TRAFFIC AND STOPPING AND BANNED TURN) ORDER 2021

 Transport for London having consulted the Royal Borough of Kensington and Chelsea hereby gives notice that it intends to make the above named Traffic Order under section 14(1) of the Road Traffic Regulation Act 1984 for the purpose specified in paragraph 2. The effect of the Order is summarised in paragraph 3.

2. The purpose of the Order is to enable gas mains connection works to take place on the A3220 Cremorne Road and Edith Grove.

- 3. The effect of the Order will be to prohibit any vehicle:
 - Road between its junction with Edith Grove and a point opposite the extended common boundary of Nos .29 and 31 Cremorne Road;

 (2) from stopping at any time at the western kerb-line of Edith Grove

(I) from stopping at any time at the northern kerb-line of Cremorne

- between the extended common boundary its junction with Cremorne Road and the extended common boundary of Nos.108 and 110 Edith Grove;
- (3) except for pedal cycles from turning right from Edith Grove into Cremorne Road.
 The Order will be effective between 8.00 AM on 28th October 2021 until
- 6.00 PM on 31st October 2021 or when the works have been completed, whichever is the sooner. The prohibition will apply only during such times and to such extent as shall from time to time be indicated by traffic signs.
- 4. The prohibitions will not apply in respect of:
 - brigade, ambulance or police purposes;
 (2) anything done with the permission or at the direction of a police

(I) any vehicle being used for the purposes of those works or for fire

- (2) anything done with the permission or at the direction of a polic constable in uniform or a person authorised by Transport for London.
- 5. At such times as the prohibition is in force an alternative route will be indicated by traffic signs via (for vehicles wishing to enter, exit or proceed onto A3220 Ashburnham Road from the junction with A308 Kings Road and Tadema Road or enter exit or proceed onto A3220 Edith Grove from the junction with A308 Kings Road (Southern junction): Tadema Road (Southbound), Lots Road (Eastbound), A3220 Cremorne Road (Eastbound), Beaufot Street (Northbound)to normal route of traffic or A308 Kings Road (Westbound), B318 Harwood Road (Northbound), A304 Fulham Road (Eastbound), A408 Fulham Road (Eastbound), Beaufort Street (Southbound) to normal route of traffic
