

LONDON BOROUGH OF LAMBETH

PROPOSALS TO PROVIDE AND REMOVE DISABLED PERSONS' PARKING PLACES IN VARIOUS ROADS

[Note: This notice is about the removal of certain disabled persons' parking places where they are no longer required and the introduction of new disabled persons' parking places where they are needed. In controlled parking zones, this will involve (a) the introduction of new parking space where the disabled persons' parking places are removed; and (b) the removal of existing parking space to accommodate the new disabled persons' parking places.]

1. NOTICE IS HEREBY GIVEN that the Council of the London Borough of Lambeth (the "Council") on the 24th September 2021 made the Lambeth (Brixton "B") (Parking Places) (No. 4) Order 2021, the Lambeth (Brixton Hill "F") (Parking Places) (No. 2) Order 2021, the Lambeth (Brixton Hill East) (Parking Places) (No. 3) Order 2021, the Lambeth (Clapham "L") (Parking Places) (No. 2) Order 2021, the Lambeth (Free Parking Places) (Disabled Persons) (No. 3) Order 2021, the Lambeth (Free Parking Places) (Limited Time) (No. 2) Order 2021, the Lambeth (Kennington) (Parking Places) (No. 3) Order 2021, the Lambeth (Stockwell) (Parking Places) (No. 4) Order 2021, the Lambeth (Streatham Hill East "M") (Parking Places) (No. 2) Order 2021, the Lambeth (Streatham Hill West "G") (Parking Places) (No. 1) Order 2021, the Lambeth (Thornton) (Parking Places) (No. 2) Order 2021, the Lambeth (Tulse Hill) (Parking Places) (No. 3) Order 2021 and the Lambeth (Vassall "V") (Parking Places) (No. 2) Order 2021 under sections 6, 45, 46, 49 and 124 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984, as amended.

2. The general effect of the Orders, which will come into force on 4th October 2021, will be to:-

- (1) to remove the disabled persons' parking places from the locations specified in Schedule 1 to this Notice;
- (2) to introduce new disabled persons' parking places at the locations specified in Schedule 2 to this Notice (these parking places will operate at any time and be for the use of vehicles displaying a disabled person's "blue badge" only);
- (3) where the locations are in a controlled parking zone, to extend any parking space adjacent to the locations specified in Schedule 1 to this Notice so as to replace the disabled persons' parking places that will be removed, and to remove any existing parking space at the locations specified in Schedule 2 to this Notice so as to accommodate the new disabled persons' parking places.

(Note: In some cases, the disabled persons' parking places may already have been removed or provided informally. Where this is the case, the effect of the Orders would be to formalise that situation so as to reflect the parking controls that currently apply on the ground and enable enforcement to be carried out if necessary.)

3. The Orders are necessary to remove certain disabled persons' parking places where they are no longer required and to provide new disabled persons' parking places so as to improve parking facilities for disabled persons where they are needed.

6. If any person wishes to question the validity of the Orders or of any of their provisions on the grounds that it or they are not within the powers conferred by the Road Traffic Regulation Act 1984, or that any requirement of that Act or of any instrument made under that Act has not been complied with, that person may, within 6 weeks from the date on which the Orders are made, apply for the purpose to the High Court.

Abbots Park, (i) outside No. 3 and (ii) outside No. 9, **Amesbury Avenue**, outside No. 168, **Effra Parade**, (i) outside No. 50 and (ii) outside No. 56, **Ellison Road**, outside Nos. 226 and 228, **Englewood Road**, outside No. 33, **Ferrers Road**, (i) outside No. 15, (ii) outside No. 35 and (iii) outside No. 36, **Hubbard Road**, outside No. 15, **Lakeview Road**, (i) outside Portobello House and (ii) outside Portobello House, **Larkhall Lane**, outside Nos. 48 and 50, **Lavengro Road**, outside No. 5, **Medora Road**, outside No. 6, **Strathbrook Road**, outside No. 72, **Telford Avenue**, outside Nos. 81 and 85, **Tivoli Road**, outside No. 125, **Turney Road**, outside Nos. 50 and 52, **Valleyfield Road**, outside No. 62, **Welby Street**, outside No. 2 and **Woodfield Avenue**, outside Nos. 33.
