## ROAD TRAFFIC REGULATION ACT 1984

### THE A4 GLA ROAD (CROMWELL ROAD/ CROMWELL GARDENS/ THURLOE PLACE/ BROMPTON ROAD, ROYAL BOROUGH OF KENSINGTON AND CHELSEA) (TEMPORARY PROHIBITION OF TRAFFIC AND STOPPING) ORDER 2021

1. Transport for London in consultation with the Royal Borough of Kensington and Chelsea hereby gives notice that it intends to make the above named Traffic Order under section 14(1) of the Road Traffic Regulation Act 1984 for the purpose specified in paragraph 2. The effect of the Order is summarised in paragraph 3.
2. The purpose of the Order is to enable highway improvement and resurfacing works to take place on the A4 Cromwell Road/ Cromwell Gardens/ Thurloe Place/Brompton Road.
3. The effect of the Order will be to prohibit any vehicle from:
  - (1) entering, exiting or proceeding on the A4 Thurloe Place/ Cromwell Gardens/Cromwell Road westbound between its junctions with A308 Brompton Road and Queen's Gate;
  - (2) entering, exiting or proceeding on the A4 Cromwell Road/ Cromwell Gardens/ Thurloe Place eastbound between its junctions with Queen's Gate and A308 Brompton Road;
  - (3) entering or proceeding on A4 Cromwell Road eastbound between its junctions Earls Court Road and Queen's Gate, local access maintained;
  - (4) stopping on A4 Cromwell Road/ Cromwell Gardens/ Thurloe Place/ Brompton Road between its junctions with Queen's Gate and Beaufort Gardens;
  - (5) entering or exiting A4 Brompton Road between its junctions with A308 Brompton Road and Beaufort Gardens.

The Order will also permit two-way operation on Brompton Square and Thurloe Square.

Works will be phased such that some restrictions will apply only at certain times.

The Order will be effective at certain times between 28th October 2021 and 31st March 2022, every night 9:00 PM until 6:00 AM or when the works have been completed whichever is the sooner. The prohibitions will apply only during such times and to such extent as shall from time to time be indicated by traffic signs.

4. The prohibitions will not apply in respect of:
  - (1) any vehicle being used for the purposes of those works or for fire brigade, ambulance or police purposes;
  - (2) anything done with the permission or at the direction of a police constable in uniform or a person authorised by Transport for London.
5. At such times as the prohibitions are in force alternative routes will be indicated by traffic signs. For eastbound traffic via Earls Court Road, Redcliffe Gardens, Fulham Road and A308 Brompton Road to normal route of travel. For westbound traffic via A308 Brompton Road, Fulham Road, Finborough Road and Warwick Road to normal route of travel. Local eastbound diversion via Queen's Gate, Kensington Gore, Kensington Road and Knightsbridge to normal route of travel.
