ROAD TRAFFIC REGULATION ACT 1984

THE A201 GLA ROAD (BLACKFRIARS BRIDGE/ BLACKFRIARS ROAD, CITY OF LONDON AND LONDON BOROUGH OF SOUTHWARK) (TEMPORARY PROHIBITION OF TRAFFIC AND STOPPING) ORDER 2021

1. Transport for London hereby gives notice that it intends to make the

- above named Traffic Order under section 14(1) of the Road Traffic Regulation Act 1984 for the purpose specified in paragraph 2. The effect of the Order is summarised in paragraph 3.

 2. The purpose of the Order is to enable a crane operation to take place
- on the A201 Blackfriars Bridge/ Blackfriars Road.
- 3. The effect of the Order will be to prohibit any vehicle from:

 (1) entering, exiting, proceeding or stopping on Blackfriars Road/

(2) entering or proceeding on the New Bridge Street southbound between its junctions with Fleet Street/ Ludgate Hill and Queen

- Blackfriars Bridge between its junctions with Queen Victoria Street and Stamford Street/Southwark Street:
- Victoria Street, except for local access;

The Order will also permit:

- (3) all vehicles to use the southbound bus gate on Blackfriars Bridge approach allowing vehicle to proceed northbound onto New Bridge
- Street;
 (4) two way operation on Upper Ground between its junctions with

Works will be phased such that some restrictions will apply only at certain times.

The Order will be effective at certain times between 19th November

2021 and 29th November 2021, every Friday night 10:00 PM until Monday 5:00 AM or when the works have been completed whichever is the sooner. The prohibitions will apply only during such times and to such extent as shall from time to time be indicated by traffic signs.

4. The prohibitions will not apply in respect of:(1) any vehicle being used for the purposes of those works or for fire

Rennie Street and Blackfriars Road.

- brigade, ambulance or police purposes;
 (2) anything done with the permission or at the direction of a police contable in uniform or a person authorised by Transport for
- constable in uniform or a person authorised by Transport for London.
- 5. At such times as the prohibitions are in force alternative routes will be indicated by traffic signs. For City westbound via Queen Victoria Street, New Bridge Street, Fleet Street, Strand, Lancaster Place, Waterloo Bridge, Waterloo Road and Stamford Street to normal route of travel. For City eastbound via Ludgate Hill, St Paul's Churchyard, Cannon Street, Queen Victoria Street, King William Street, London Bridge, Borough High Street and Southwark Street to normal route of travel. For Southwark eastbound via Southwark Street, Borough High Street, London Bridge, King William Street, Queen Victoria Street, Cannon Street, St Paul's Churchyard and Ludgate Hill to normal route of

travel. For Southwark westbound via Stamford Street, Waterloo Road, Waterloo Bridge, Lancaster Place, Aldwych, Strand and Fleet
