THE A24 GLA ROAD (LONDON ROAD/CROWN ROAD/CROWN LANE/ EPSOM ROAD, LONDON BOROUGH OF MERTON) (TEMPORARY PROHIBITION OF TRAFFIC AND STOPPING) ORDER 2021 1. Transport for London in consultation with the London Borough of

Merton hereby gives notice that it has made the above named Traffic

- Order under section 14(1) of the Road Traffic Regulation Act 1984 for the purpose specified in paragraph 2. The effect of the Order is summarised in paragraph 3. 2. The purpose of the Order is to enable highway improvement and
- resurfacing works to take place on the A24 London Road/ Crown Lane/ Crown Road/ Epsom Road.
- 3. The effect of the Order will be to prohibit any vehicle from:
 - (I) entering, exiting, proceeding or stopping on A24 London Road between its junctions with Morden Hall Road/ Morden Road and
 - A24 Epsom Road; entering, exiting, proceeding or stopping on A24 Epsom Road between its junctions with A24 London Road and Rutland Drive;
 - Road northbound between its junction with Cheam Common Road and Rutland Road, except access; entering, exiting or proceeding on Crown Lane between its

entering or proceeding on A24 London Road/ Stonecot Hill/ Epsom

- junctions with Links Avenue/Poplar Road South and London Road; stopping on A24 Crown Lane between its junctions with Crown
- Road and London Road:
- (6) entering, exiting, proceeding or stopping on A24 Crown Road between its junctions with London Road and Crown Lane;
- entering, exiting or proceeding on Aberconway Road between its (7)junctions with Morden Hall Road and London Road, local access will be maintained between Morden Hall Road and Abbotsbury Road:
- entering Abbotsbury Road between its junctions with Aberconway Road and London Road, local access maintained; entering Morden Underground Station Car Park at its junction with (9)
- Kenley Road;
- (10) stopping in the Loading bay outside No.12 Morden Hall Road; (11) stopping on Central Road between its junctions with London Road/ Epsom Road and the roundabout at the junctions of Morden Road/

St Helier Avenue/Morden Hall Road;

- (12) entering or proceeding on Martin Way between its junctions with Bushey Road and Links Avenue, except local access; The Order will also permit: (13) all vehicles to use bus lanes on A24 London Road between its
- junctions with Morden Hall Road/ Morden Road and A24 Epsom Road; (14) two way operation on Abbotsbury Road between its junctions with
- Aberconway Road and London Road; (15) buses to stop on London Road between its junctions with Crown
- Lane and Crown Road, Crown Lane between its junctions with Crown Road and London Road and Crown;
- (16) buses to stop on Central Road between its junctions with London Road/ Epsom Road and the roundabout at the junctions of Morden
- Road/ St Helier Avenue/ Morden Hall Road. Works will be phased such that some restrictions will apply only at certain times.
- The Order will be effective at certain times between 28th November 2021 and 30th April 2022, every night 9:00 PM until 5:00 AM or when the works have been completed whichever is the sooner. The
- prohibitions will apply only during such times and to such extent as shall from time to time be indicated by traffic signs.
- 4. The prohibitions will not apply in respect of: (I) any vehicle being used for the purposes of those works or for fire
 - brigade, ambulance or police purposes; (2) anything done with the permission or at the direction of a police
 - constable in uniform or a person authorised by Transport for London.
- 5. At such times as the prohibitions are in force alternative routes will be indicated by traffic signs via Epsom Road, Stonecot Hill, London Road, Cheam Common Road, Central Road, Malden Road, Malden Junction, A3 Kingston Bypass, Bushey Road, Kingston Road, Merton Park Parade, Kingston Road, Merton High Street, Priory Road, Christchurch Road,

Merantun Way and Morden Road or reverse to normal route of travel.
