ROAD TRAFFIC REGULATION ACT 1984 - SECTION 14

TEMPORARY ROAD CLOSURES AND ONE WAY TRAFFIC SYSTEMS IN ALDEBERT TERRACE, BOLNEY STREET, CARROUN ROAD, DORSET ROAD, KIBWORTH STREET, OLD SOUTH LAMBETH ROAD, ST STEPHEN'S TERRACE, TRADESCANT ROAD AND WALBERSWICK STREET

1. NOTICE IS HEREBY GIVEN that, to enable telecommunications infrastructure works to be carried out, the Council of the London Borough of Lambeth have made an order the effect of which will be to temporarily:

- (a) in **Aldebert Terrace**, ban vehicles (except cycles) from travelling in a westerly direction;
- (b) in **Bolney Street** (north-east to south-west arm), ban vehicles (except cycles), from travelling in a southerly direction, between Dorset Road and Wilkinson Street;
- (c) in **Carroun Road** ban vehicles from entering that section, which lies between Dorset Road and Oval Place;
- (d) in **Dorset Road**:
 - (i) ban vehicles from entering that section, which lies between Meadow Road and Bolney Street;
 - (ii) ban vehicles from travelling in a westerly direction between Bolney Street and Carroun Road;
 - (iii) ban vehicles (except cycles) from travelling in an easterly direction, between Carroun Road and Kibworth Street;
 - (iv) ban vehicles (except cycles) from travelling in an easterly direction, between Kibworth Street and Cobbett Street;
- (e) in **Kibworth Street**, ban vehicles from entering that section, which lies between Dorset Road and Oval Place;
- (f) in **Old South Lambeth Road**, ban vehicles (except cycles) from entering that section, which lies between Dorset Road and Meadow Place;
- (g) in **St Stephen's Terrace**, ban vehicles (except cycles) from travelling in a northerly direction;
- (h) ban vehicles from entering **Tradescant Road**; and
- (i) ban vehicles from entering **Walberswick Street**.

2. Alternative routes for affected vehicles will be available:

- (a) for 1(a) above via (i) Albert Square, Wilkinson Street and St Stephen's Terrace; and (ii) St Stephen's Terrace, Bolney Street, Dorset Road, Meadow Road and Fentiman Road;
- (b) for 1(b) above via Dorset Road, Old South Lambeth Road, South Lambeth Road, Aldebert Terrace and St Stephens Terrace;
- (c) for 1(c) above via Carroun Road, Oval Place, Kibworth Street and Dorset Road;
- (d) for 1(d) above via Dorset Road, Carroun Road, Fentiman Road, Meadow Road and Dorset Road; (ii) Carroun Road, Fentiman Road and Meadow Road; (iii) Carroun Road, Oval Place and Kibworth Street; and (iv) Kibworth Street, Oval Place and Palfrey Place;
- (e) for 1(e) above via Dorset Road, Carroun Road, Oval Place and Kibworth Street;
- (f) for 1(f) above via Old South Lambeth Road and South Lambeth Road;
- (g) for 1(g) above via (i) Wilkinson Street, Albert Square and Aldebert Terrace; and (ii) Aldebert Terrace, Albert Square and Wilkinson Street;
- (h) for 1(h) above via (i) Walberswick Street and South Lambeth Road; and (ii) Tradescant Road, South Lambeth Road, Alderbert Terrace and St Stephen's Terrace; and
- (i) for 1(i) above via Tradescant Road and South Lambeth Road.

3. The bans will only apply at such times and to such extent as shall be indicated by the placing of the appropriate traffic signs.

4. The Order will come into force on 17th January 2022 and will continue for a maximum duration of 18 months (to allow for contingencies) or until the works have been completed whichever is the earlier. In practice it is anticipated that the works will be undertaken in 1 / 2 street units at any time and each street unit will be carried out in short phases of 3 - 5 days. The works will be coordinated to avoid diversions overlapping.
