(Temporary Prohibition of Traffic) Order 2022
NOTICE IS HEREBY GIVEN that Lewisham Council intend to make the

above named temporary traffic Order under the provisions of section 14(1) of the Road Traffic Regulation Act 1984 because of night time carriageway works on and adjacent to the highway. The effects of the Order shall be as indicated below.

1. (1) Road closures in the following roads, for one night, starting on the

date shown:- (i) Allerford Road, between Southend Lane and 118 & 120 Allerford Road. (13th Nov 2022) (ii) Blackheath Grove, between Blackheath Village and 14 2 Blackheath Grove, L28th Nov. 2022) (iii) Blackheath Village, between Bennett Park and Tranquil Vale. (28th Nov. 2022) (iv) Friendly Street, between Brookmill Road and Vanguard Street. (29th Nov 2022) (vi) Giffin Street, for 30m from Deptford Church Street. (28th Nov 2022) (vi) Harefield Road, between Brockley Road and 1 & 3 Harefield Road. (30th Nov 2022) (vii) Moremead Road, between Southend Lane and rear boundary of 298 Southend Lane. (13th Nov 2022) (viii) Sandhurst Road, between Verdant Lane and Wellmeadow Road.

- (13th Nov 2022) (ix) Southend Lane, eastbound only, between Sainsbury SavaCentre and Firhill Road. (13th Nov 2022) (x) St Germans Road, between Brockley Rise and Park Rise Road. (1st Dec 2022) (x) Wickham Road, between Brockley Road and Breakspears Road. (1st Dec 2022) (2) The diversion routes for traffic affected by the prohibitions shall be via local neighbouring roads and will be as signed on the ground.

 2. No right turn into Station Road from Lewisham High Street. (30th Nov 2022)

 3. Suspension of the one way working in (i) Frankham Street, the section of behind Nos. 80 to 92 Deptford High Street; and (ii) Giffin Street, during the works. (28th Nov 2022) (Note: Dates shown in articles 1, 2 and 3 above are liable to change.)
- 5. The Order is intended to come into force on the 13th November 2022 to remain in force for 3 months or until the works are complete, whichever is the sooner.

4. Exemption will be provided in the Order for vehicles engaged on the works, vehicles being used for ambulance, fire brigade or police purposes in an emergency and anything done with the permission or at the direction

6. The prohibitions will apply as, when and to the extent signed on the highway.
