THE A23 GLA ROAD AND GLA SIDE ROAD (BRIXTON HILL/ BRIXTON ROAD, LONDON BOROUGH OF LAMBETH) (TEMPORARY PROHIBITION OF TRAFFIC AND STOPPING) (No.2) ORDER 2022

- Transport for London in consultation with the London Borough of Lambeth hereby gives notice that it has made the above named Traffic
- Order under section 14(1) of the Road Traffic Regulation Act 1984 for
- the purpose specified in paragraph 2. The effect of the Order is summarised in paragraph 3.
- The purpose of the Order is to enable highway improvement and resurfacing works to take place on the A23 Brixton Hill/Brixton Road.
- 3. The effect of the Order will be to prohibit any vehicle from: entering, exiting or proceeding in a southerly direction on A23
- Brixton Road/ Brixton Hill between its junctions with Camberwell New Road and St Matthew's Road, local access will be maintained between Camberwell New Road and Gresham Street;
- (2)entering or proceeding on Effra Road between its junctions with Brixton Hill and Saltoun Road;
 - entering, proceeding on Coldharbour Lane between its junctions (3)with Atlantic Road and Brixton Road, local access will be
 - maintained between Atlantic Road and Electric Lane; (4)entering or proceeding on Electric Avenue between its junctions with Electric Lane and Brixton Road;
 - (5)entering or proceeding on Atlantic Road between its junctions
 - with Electric Lane and Brixton Road; (6)
 - entering or proceeding in an easterly direction on Acre Lane between its junctions with Trinity Gardens and A23 Brixton
 - Road/Brixton Hill; (7)entering or proceeding in a westerly direction on Acre Lane between its junctions with A23 Brixton Road/Brixton Hill and

- Buckner Road; (8) entering, exiting or proceeding in a northerly direction on A23 Brixton Hill/ Brixton Road between its junctions with Streatham Place/ Brixton Water Lane and Ferndale Road, local access will be
- maintained between Streatham Place/ Brixton Water Lane and Sudbourne Road;
- and Stockwell Road; (10) entering or proceeding on Brighton Terrace between its junctions Bernay's Grove and Brixton Road.

stopping on Brixton Road between its junctions with Baytree Road

- The Order will also:
- (11) permit all vehicles to use the northbound and southbound bus lanes on A23 Brixton Road/ Brixton Hill between its junctions with St Matthew's Road and Gresham Street;
- (12) permit all vehicle to turn right from Baytree Road into Brixton Hill southbound.

Works will be phased such that some restrictions will apply only at

The Order will be effective at certain times between 23rd October 2022 and 23rd April 2022, every night 9:00 PM until 6:00 AM or when the works have been completed whichever is the sooner. The prohibitions will apply only during such times and to such extent as shall from time to time be indicated by traffic signs.

certain times. Residential access will be maintained.

- The prohibitions will not apply in respect of: any vehicle being used for the purposes of those works or for fire
 - brigade, ambulance or police purposes;
 - anything done with the permission or at the direction of a police constable in uniform or a person authorised by Transport for London.
- At such times as the prohibitions are in force alternative routes will be 5. indicated by traffic signs. Northbound diversion via Streatham Place, Atkins Road, Poynders Road, Cavendish Road, Clapham Common South Side, The Avenue, Clapham Common South Side, Clapham High Street, Clapham Road, Kennington Park Road and Camberwell New Road to normal route of travel. Southbound diversion via Camberwell New Road, Kennington Park Road, Clapham Road, Clapham High

Street, Clapham Common South Side, Cavendish Road, Poynders Road,

Atkins Road and Streatham Place to normal route of travel.
