CLAPHAM COMMON The London Borough of Lambeth has applied to the Secretary of State for Environment.

Food and Rural Affairs for consent under article 12 of the Greater London Parks and Open Spaces Order 1967 to carry out restricted works on Clapham Common. The Planning Inspectorate will decide the application on behalf of the Secretary of State. The proposed works are related to the second phase of improvement works planned along the middle section of Windmill Drive, a public highway crossing through Clapham Common. The aim of the scheme is to make the existing trial modal filter - which stops

motor vehicles from entering this section and allows for a shared-use cycle lane and pedestrian footpath - permanent with associated works to the highway. This application focuses on the section of Windmill Drive at the western end of the scheme's site boundary, where the north-south pedestrian and cycle paths converge at the junction of Windmill Drive, north-west of the Bandstand Beds entrance. A key element of the scheme is re-aligning the existing cycle route to more closely match desire lines and provide a larger space for pedestrians and cycles to negotiate this iunction, where several pedestrian routes and key cycle routes converge/cross over one another, including Quietway 5, London Cycle Network routes 3, 5 and 25, and Avenue Verte, the London to Paris cycle route. The design was developed to address these issues of conflict by providing more space for all and encouraging negotiation through the concentric ring 'roundabout' treatment. In order to deliver the full implied roundabout treatment at this location and realise the full benefits of the scheme, it is proposed that small sections of the existing paths will be removed (36.25sqm net loss

of green space:), and some areas of grassland de-paved and returned to green space (37.95sgm net gain of green space). There will be a net gain of approximately 1.7sgm of green to the Common overall.
