- made the above named Orders, under section 6 of the Road Traffic Regulation Act 1984. The Orders will come into force on 18th February 2023. 2. The general nature and effect of the Orders would be to:
 - (I) allow two way operation on Victoria Street between its junctions
 - with Wilton Road and Bressenden Place;
 - (2) ban all vehicles proceeding northwards Wilton Road from turning right into Victoria Street, except local buses and pedal cycles;
 - (3) re-introduce the westbound bus lane on Victoria Street between its junctions with Wilton Road and Buckingham Palace Road, operating
 - Monday to Sunday 'At Any Time' permitting Buses, Dial-a-Ride Buses, Pedal Cycles, Taxis and Solo Motorcycles to use it;
 - (4) removed Red Route controls and double red lines from Allington Street at its junctions with Victoria Street and Bressenden Street; (5) redefine TfL Side Road extents on Victoria Street northside to a point 6.3 metres west of a point opposite the common boundary of Nos.
 - 155 and 157 Victoria Street; (6) redefine TfL Side Road extents on Victoria Street southside to a point 4.6 metres west of the common boundary of Nos. 155 and
 - 157 Victoria Street: (7) Remove the Loading and Disabled Persons Vehicle bay on Bressenden Place southwestern side north of its junction with Victoria Street and introduce a 26 metres inset Loading only bay
- operating No Stopping at any Time except Loading 40 minutes; 3. Introduce a 10 metre Motorcycle only bay opposite No.10 Bressenden Place operating No Stopping At Any Time Except Solo Motor bicycles only
