

LONDON BOROUGH OF LAMBETH
PROPOSED AMENDMENT TO PARKING PLACES -
TROUVILLE ROAD

[NOTE: This Notice is about proposals to remove a section of permit holders parking place outside Nos. 29 and 30 Trouville Road and replace it with single yellow line no waiting restrictions that would operate at Controlled Parking Zone hours to allow for the installation of a dropped kerb. Objections or other comments may be made – see paragraph 6.]

1. NOTICE IS HEREBY GIVEN that the Council of the London Borough of Lambeth proposes to make The Lambeth (Free Parking Places, Loading Places and Waiting, Loading and Stopping Restrictions) (Amendment No. *) Order 202* and The Lambeth (Charged-For Parking Places) (Amendment No. *) Order 202* under sections 6, 45, 46, 49 and 124 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984, as amended.

2. The general effect of the Orders would be to replace a section of permit holders parking place with single yellow line no waiting restrictions that would operate at Controlled Parking Zone hours (Monday to Friday, 9am to 6pm) on Trouville Road, the south-west side, between a point in line the north-western boundary of Nos. 29 and 30 Trouville Road and a point 7 metres south-eastwards of that boundary.

3. The Orders are necessary to accommodate a new vehicle crossover outside Nos. 29 and 30 Trouville Road and prevent obstruction of access.
