

## **LONDON BOROUGH OF LAMBETH**

### **PERMANENT WAITING RESTRICTIONS, REMOVAL OF SHARED-USE PARKING PLACES AND RELOCATION OF MOTORCYCLE PARKING PLACE IN THE CUT**

*[NOTE: This Notice is about the permanent removal of lengths of shared use parking places replaced with "at any time" waiting restrictions and relocation of a motorcycle parking place in The Cut].*

1. NOTICE IS HEREBY GIVEN that the Council of the London Borough of Lambeth, on 4th August 2023 made the Lambeth (Charged-For Parking Places) (Amendment No. 14) Order 2023 and the Lambeth (Free Parking Places, Loading Places and Waiting, Loading and Stopping Restrictions) (Amendment No. 14) Order 2023 under sections 6, 45, 46, 49 and 124 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984. The Orders will come into force on 6th August 2023.

2. The general effect of the Orders will be to permanently:

- (a) remove lengths of Waterloo 'W' shared-use parking places in lay-bys in The Cut: the north-west side: outside No. 90 The Cut (5.5 metres removed) and outside Nos. 108 and 110 The Cut (5.5 metres removed); and on the south-eastside: outside Nos. 65 and 67 The Cut (6 metres removed); opposite Nos. 98 and 100 The Cut (5 metres removed) and opposite Nos. 108 and 110 The Cut (5 metres removed) and in those lengths provide a ban on waiting by vehicles 'at any time';
- (b) remove a 5-metre length of the Waterloo 'W' shared-use parking place in the lay-by in The Cut, the southeast side, opposite No. 106 The Cut and in that length provide a motorcycle parking place; and
- (c) remove the motorcycle parking place in The Cut, the south-east side, opposite Nos. 98 and 100 The Cut and in that length provide a ban on waiting by vehicles at any time'.

3. The Orders are necessary to permanently provide space for the provision of parklets, which were introduced under an experimental scheme in February 2022.

6. If any person wishes to question the validity of the Orders or of any of their provisions on the grounds that they are not within the powers conferred by the Road Traffic Regulation Act 1984, or that any requirement of that Act or of any instrument made under that Act has not been complied with, that person may, within 6 weeks from the date on which the Orders are made, apply for the purpose to the High Court.
