

## TRAFFIC MANAGEMENT ORDER

**The Lewisham (Free Parking Places, Loading Places and Waiting, Loading and Stopping Restrictions) (Consolidation) (Amendment No \*) Order 202\***

**The Lewisham (Charged for Parking Places) (Consolidation) (Amendment No \*) Order 202\***

The Council of the London Borough of Lewisham proposes to make the above Traffic Regulation Orders under the Road Traffic Regulation Act 1984 (as amended).

1. The effect of these proposals is as follows:

**PTO 1022** The effect of the above orders will be to introduce the following restrictions to facilitate the introduction of a Residents Parking Permit scheme Monday to Friday between 9am and 5pm.

A. No waiting at any time

**Grierson Street** a) extend outside Nos 85/95/97/107/109; b) junction protection on both sides north and south of Honor Oak Park.

**Honor Oak Park** extend on south side of east of Grierson Road.

**Ballina Street** extend junction protection on both sides at junctions with Honor Oak Park and Gabriel Street.

B. No waiting Monday to Friday 9am – 5pm

**Grierson Road** across each identified vehicle dropped crossing (including driveways) not including No 208. **Ballina Street** across each identified vehicle dropped crossing (including driveways)

C. Resident permit holders only

**Grierson Road** on both sides of at various locations between No 208 and 110; **Ballina Street** on both sides of at various location

D. Pay by phone and permit holders

**Grierson Road** on the east side along No 63 Honor Oak Park.

**Ballina Street** outside No 33

E. Pay by phone and resident permit holders

**Grierson Road** a) on the east side of along No 63 Honor Oak Park; b) on the east side along No 68 Gabriel Street.

**Ballina Street** a) on both side of along No 43 and 45 Honor Oak Park; b) on the east side along No 36 Gabriel Street.

F. Blue badge holders

**Grierson Road** a) outside No 166; b) outside No 123; c) outside 133; d) outside No 144.

**Ballina Street** a) outside No 6; b) outside No 5; c) outside No 16

G. Car club

**Grierson Road** on the west side outside No 168.

**Ballina Street** on the east side along No 35

H. Electric vehicle only

**Grierson Road** on the east side opposite No 66.
