SOUTH, LONDON BOROUGH OF CROYDON) (TEMPORARY BANNED TURN) ORDER 2023

2. The purpose of the Order is to enable drainage

- I. Transport for London hereby gives notice that it intends to make the above named Traffic Order under section 14(1) of the Road Traffic Regulation Act 1984 for the purpose specified in paragraph 2. The effect of the Order is summarised in paragraph 3.
- investigation works to take place on the A22 Godstone Road, Purley Road, Russell Hill Road, Foxley Lane, Banstead Road and Whytecliffe Road South.
- 3. The effect of the Order will be to prohibit any vehicle from;
 - (1) Turning right into High Street from Whytecliffe Road South:
 - (2) Stopping in the Loading Unloading and Disabled Persons' Vehicle bay outside Nos 12-16 Whytecliffe Road South; (3) Stopping in the Loading Unloading and Disabled Persons'
 - Vehicle bay opposite Nos. 20-22 Whytecliffe Road South: (4) Stopping on Russell Hill Road between its junctions with
 - Foxley Lane and Brighton Road;
 - (5) Stopping on Foxley Lane between its junctions with Banstead Road and Pampisford Road;

- (6) Stopping on Purley Road between its junctions with High
- Street and Brighton Road: (7) Stopping on Banstead Road between its junctions with
 - Brighton Road and Foxley Lane;
- (8) Stop on Godstone Road between its junction Whytecliffe Road South and the southern building line of No.2 Godstone Road.

The Order will be effective at certain times between 11th September 2023 and 19th January 2024 every night from 9:00 PM to 05:00 AM or when the works have been completed whichever is the sooner. The prohibition will apply only during such times and to such extent as shall from time to time be indicated by traffic signs.

4. The prohibitions will not apply in respect of:

Dated this 1st day of September 2023

- (I) any vehicle being used for the purposes of those works or for fire brigade, ambulance or police purposes;
- (2) anything done with the permission or at the direction of a police constable in uniform or a person authorised by Transport for London.
- 5. At such times as the prohibition is in force an alternative route will be indicated by traffic signs via Purley Road, Purley Road Roundabout and Purley Road to normal route of travel.
