THE A3220 AND A3212 GLA ROADS (BATTERSEA BRIDGE ROAD, BATTERSEA BRIDGE, CHEYNE WALK AND CHELSEA EMBANKMENT, LONDON BOROUGH OF WANDSWORTH AND ROYAL BOROUGH OF KENSINGTON & CHELSEA) (TEMPORARY PROHIBITION OF STOPPING AND SUSPENSION OF BUS LANE) ORDER 2024

- I. Transport for London in consultation with the London Borough of Wandsworth hereby gives notice that it has made the above named Traffic Order under section 14(1) of the Road Traffic Regulation Act 1984 for the purpose specified in paragraph 2. The effect of the Order is
- 2. The purpose of the Order is to enable coring works to take place on Battersea Bridge Road.
- 3. The effect of the Order will be to prohibit any vehicle from:
 - (1) stopping on A3220 Cheyne Walk/Chelsea Embankment between its junctions with Danvers
 - Street and Oakley Street;
 - (2) stopping on A3220 Battersea Bridge Road between its junctions with Hester Road and Westbridge Road;
 - Westbridge Road;
 (3) stopping on A3220 Battersea Bridge Road between its junctions with Westbridge Road and Cambridge Road;
 - Battersea Bridge Road;
 (5) stopping in the Parking & Disabled Persons' Vehicles Bay outside Nos. 1 5 Battersea Church

(4) stopping in the Loading/Unloading & Disabled Persons' Vehicles Bay outside Nos. 64 - 66

- Road;
 (6) stopping in the Parking & Disabled Persons' Vehicles Bay outside Nos. 2 8 Battersea Church
- (7) stopping in the Parking & Disabled Persons' Vehicles Bay outside Nos. 204 208 Battersea Bridge Road;
- (8) stopping in the Parking & Disabled Persons' Vehicles Bay outside Nos. 191a 207 Battersea Bridge Road;
- (9) stopping in the Parking & Disabled Persons' Vehicles Bay from outside Nos. 211 Battersea Bridge Road to outside Nos. 50 - 81 Cambridge Mansions;
 (10) stopping on Ethelburga Street between its junctions with Battersea Bridge Road and Henty
- Close;

 (11) stopping on the northern side of Battersea Church Road from the extended eastern building
- (11) stopping on the northern side of Battersea Church Road from the extended eastern building line of Nos. 4 8 Battersea Church Road and its junction with A 3220 Battersea Bridge Road;
 (12) stopping on the southern side of Battersea Church Road from a point 1 metre north-east of
- the extended common boundary of Nos. 5 and 7 Battersea Church Road and its junction with A3220 Battersea Bridge Road;

 (13) stopping on Hyde Lane from a point 3 metres south-west of the extended north-eastern
- building line of No. 112 Battersea Bridge Road to its junction with Battersea Bridge Road. This Order will also permit all vehicles to use the north-westbound bus lane on Battersea Bridge Road between the extended common boundary of Nos. 1 2 Mansel Court and outside Musgrave Court, Battersea Bridge Road.
- The Order will be effective at certain times from 12th February 2024 until 21st July 2024 every night from 9:00 PM to 5:00 AM or when the works have been completed whichever is the sooner. The prohibitions will apply only during such times and to such extent as shall from time to time be indicated by traffic signs.
- 4. The prohibitions will not apply in respect of:
- (I) any vehicle being used for the purposes of those works or for fire brigade, ambulance or police
 - purposes;
 (2) anything done with the permission or at the direction of a police constable in uniform or a
- person authorised by Transport for London.
