ROAD TRAFFIC REGULATION ACT 1984 THE A23 GLA ROAD (BRIXTON ROAD AND SIDE ROADS, LONDON BOROUGH OF LAMBETH) (TEMPORARY PROHIBITION OF TRAFFIC, STOPPING AND BANNED TURNS) ORDER 2024

- Transport for London in consultation with the London Borough of Lambeth hereby gives notice that it intends to make the above named Traffic Order under section 14(1) of the Road Traffic Regulation Act 1984 for the purpose specified in paragraph 2. The effect of the Order is summarised in paragraph 3.
- The purpose of the Order is to enable carriageway and resurfacing works to take place on the A23 Brixton Road.
- 3. The effect of the Order will be to prohibit any vehicle from:
 - (I) entering, exiting, stopping or proceeding on Brixton Road between its junctions with Camberwell New Road and Acre Lane;
 - (2) entering, exiting, stopping or proceeding on Prima Road between its junction with Offley Road and Brixton Road;
 - (3) entering, exiting, stopping or proceeding on Offley Road between the extended common boundary of Nos. 62 and 64 to its junction with Brixton Road;
 - (4) entering, exiting, stopping or proceeding on the access roads to Lincoln House and Canterbury Court at the junction with Brixton Road:
 - (5) entering, exiting, stopping or proceeding on Cranmer Road between its junctions with Bowhill Close and Brixton Road;
 - (6) entering, exiting, stopping or proceeding on Handforth Road between the extended common boundary of Nos. 10 & 12 Handforth Road and its junction with Brixton Road;
 - (7) entering, exiting, stopping or proceeding on Crewdson Road between the extended common boundary of Nos. 12 and 14 Crewdson Road and its junction with Brixton Road;
 - (8) entering, exiting, stopping or proceeding on South Island Road between the extended common boundary of Nos. 8 and 10 South Island Road;
 - (9) entering, exiting, stopping or proceeding on Mowell Street between the extended common boundary of Nos. I-6 and 7-I2 Glencoe Mansions, Mowell Street to its junction with Brixton Road;
 - (10) entering, exiting, stopping or proceeding on Caldwell Street from the western common boundary of No. 70 Caldwell Street to its junction with Brixton Road;
 - (11) entering, exiting, stopping or proceeding on Vassall Road from the western common boundary of Landerdale House, Vassall Road to its junction with Brixton Road;
 - (12) entering, exiting, stopping or proceeding on Southey Road between its junctions with Cranworth Gardens and Brixton Road:
 - (13) entering, exiting, stopping or proceeding on Hillyard Street between its junctions with Pembry Close and Brixton Road;
 - (14) entering, exiting, stopping or proceeding on Normandy Road between its junctions with Melbourne Mews and Brixton Road;
 - (15) entering, exiting, stopping or proceeding on Groveway between its junctions with the access road to the rear of No. Groveway and Brixton Road;
 - (16) entering, exiting, stopping or proceeding on Melbourne Mews at its junction with Brixton Road;
 - (17) entering, exiting, stopping or proceeding on Mostyn Road between its junctions with Evesham Walk and Brixton Road;
 - (18) entering, exiting, stopping or proceeding on Lorn Road between its junctions with Lorn Court and Brixton Road:
 - (19) entering, exiting, stopping or proceeding on Ingleton Street at its junction with Brixton Road;
 - (20) entering, exiting, stopping or proceeding on Burton Road at its junction with Brixton Road;
 - (21) entering, exiting, stopping or proceeding on Robsart Street from the eastern extended common boundary of No. 6 Robsart Street
 - to its junction with Brixton Road;
 (22) entering, exiting, stopping or proceeding on Thornton Street from the western extended building line of No. 298 Brixton Road to its junction with Brixton Road;
 - (23) entering, exiting, stopping or proceeding on Wynne Road at its junction with Brixton Road:
 - (24) entering, exiting, stopping or proceeding on Villa Road from the extended common boundary of Nos. 5 and 7 Villa Road to its junction with Brixton Road:
 - (25) entering, exiting, stopping or proceeding on St Johns Crescent from the western extended boundary of No. 2 St Johns Crescent to its junction with Brixton Road;
 - (26) entering, exiting, stopping or proceeding on Gresham Road between its junctions with Wiltshire Road and Brixton Road;
 - (27) entering, exiting, stopping or proceeding on Ferndale Road at its junction with Brixton Road;(28) entering, exiting, stopping or proceeding on Atlantic Road from its
 - junctions with Electric Lane and Brixton Road; (29) entering, exiting, stopping or proceeding on Stockwell Park Road

- from its junctions with Stockwell Road and Brixton Road;
- (30) entering, exiting, stopping or proceeding on Stockwell Road from its junctions with Stansfield Road and Stockwell Park Road, except for buses and pedal cycles;
- (31) turning left from Caldwell Street onto Brixton Road;
- (32) turning left from Vassall Road onto Brixton Road;
- (33) turning right from Caldwell Street onto Brixton Road;
- (34) turning right from Vassall Road onto Brixton Road; (35) turning left from Stockwell Park Walk into Brixton Road
- (36) turning into Gresham Road from Wiltshire Road.

The Order will also:

- (37) permit pedal cycles to use the south-western footway of Camberwell New Road from outside of Lincoln House to the western kerb of Brixton Road;
- (38) permit pedal cycles to use the western footway of Brixton Road from its junctions with Camberwell New Road and Stockwell Road;
- (39) permit pedal cycles to use the eastern footway of Brixton Road from its junctions with Camberwell New Road and Stockwell Road;
- (40) permit pedal cycles to use the northern footway of Stockwell Park Walk from outside of Albemarle House to its junction with Brixton Road;
- (41) permit pedal cycles to use the northern footway of Acre Lane from outside No. 8 Acre Lane to its junction with Brixton Road;
- (42) permit pedal cycles to use the western footway of Brixton Hill from outside Lambeth Town Hall to its junction with Brixton Road;
- (43) suspend the disabled persons' vehicles bay in Wynne Road at the side of No. 322 Brixton Road;
- (44) suspend the disabled persons' vehicles bay in Villa Road on the northern kerbline at its junction with Brixton Road;
- (45) suspend the parking and disabled persons' vehicles bay in Mowell Street at the side of Christ Church;
- (46) suspend the parking and disabled persons' vehicles bay in South Island Place at the side of No. 68 Brixton Road;(47) suspend the parking and disabled persons' vehicles bay in
- Crewdson Road at the side of No. 64 Brixton Road;
- (48) suspend the parking and disabled persons' vehicles bay in Handforth Road at the side of No. 52 Brixton Road.

Works will be phased such that some restrictions will apply only at certain times.

Local access will be maintained.

The Order will be effective at certain times between 28th February 2024 and 31st July 2024 every night 9:00 PM to 6:00 AM or when the works have been completed whichever is the sooner. The prohibition will apply only during such times and to such extent as shall from time to time be indicated by traffic signs.

- 4. The prohibitions will not apply in respect of:
 - (1) any vehicle being used for the purposes of those works or for fire brigade, ambulance or police purposes;
 - (2) anything done with the permission or at the direction of a police constable in uniform or a person authorised by Transport for London.
- 5. At such times as the prohibitions are in force an alternative route will be indicated by traffic signs for **northbound** traffic via Stockwell Road, Clapham Road and Harleyford Street to normal route of travel. For southbound traffic via Harleyford Street, Clapham Road, Stockwell Road and Stockwell Park Walk to normal route of travel. For traffic wanting to access Brixton Road during the first and second phase via Camberwell New Road and Vassall Road to normal route of travel and the other way around. For traffic wanting to access Brixton Road during the third, fourth and fifth phase northbound via Mostyn Road, Akerman Road, Patmos Road, Fredrick Crescent, Elliott Road, Vassall Road and Camberwell New Road to normal route of travel. For traffic wanting to access Brixton Road during the third, fourth and fifth phase southbound via Camberwell New Road, Vassall Road, Langton Road, Lothian Road, Akerman Road and Mostyn Road to normal route of travel. For traffic wanting to access Brixton Road during the sixth, seventh and eighth phase northbound via Stockwell Road, Clapham Road and Caldwell Street to normal route of travel. For traffic wanting to access Brixton Road during the sixth and seventh phase southbound via Camberwell New Road, Vassall Road, Caldwell Street, Clapham Road, Stockwell Road and Stockwell Park Walk to normal route of travel. For traffic wanting to access Brixton Road during the eighth and ninth phase via Brixton Hill, Acre Lane, Clapham Park Road, Clapham High Street, Clapham Road and Harleyford Street to normal route of travel and the other way around. For traffic wanting to access Brixton Road during the eighth and ninth phase southbound via Loughborough Road and Coldharbour Lane to normal route of travel.
