- above named Traffic Order under section 14(1) of the Road Traffic
- Regulation Act 1984 for the purpose specified in paragraph 2. The effect of the Order is summarised in paragraph 3. 2. The purpose of the Order is to allow resurfacing works to take place on
- A3203 Lambeth Bridge.
- 3. The effect of the Order will be to prohibit any vehicle from:
 - entering or proceeding on Lambeth Bridge between its junctions with Millbank and Albert Embankment/Lambeth Palace Road;
 - (2) Entering, exiting or proceeding on Millbank between its junctions

junctions with Thorney Street and Millbank;

- with Dean Stanley Street and Ponsonby Place; (3)entering, exiting or proceeding on Horseferry Road between its
- Turning right on Millbank Roundabout onto the Southern Arm of Millbank. Works will be phased such that some restrictions will apply only at
- certain times. The Order will be effective from 7:00 AM on 28th April 2024 until 7:00 PM on 4th August 2024 for articles (1), (2) and (3) or when those works have been completed, whichever is the sooner, and from 28th April until 17th June, every Saturday and Sunday from 8:00 AM to 4:00 PM for article (4). The prohibitions will apply only during such times and to
- such extent as shall from time to time be indicated by traffic signs. 4. The prohibitions will not apply in respect of: any vehicle being used for the purposes of those works or for fire brigade, ambulance or police purposes;
 - (2) anything done with the permission or at the direction of a police constable in uniform or a person authorised by Transport for London.
- 5. At such times as the prohibitions are in force an alternative route will be indicated by traffic signs via: [For vehicles travelling westbound on Lambeth Bridge] Lambeth Palace Road, Westminster Bridge Road, Parliament Square, Victoria Street, Great Smith Street, Marsham Street and reverse to normal route of travel OR Lambeth Palace Road, Westminster Bridge Road, Parliament Square, Abingdon Street and reverse to normal route of travel. [For vehicles travelling eastbound on Lambeth Bridge] Marsham Street, John Islip Street, Bessborough Gardens, Vauxhall Bridge Road, Albert Embankment and reverse to normal route of travel. [For vehicles travelling to Southern Arm of Millbank] Lambeth Bridge, Lambeth Road Roundabout, Lambeth Bridge
